The Pocono Mountains offered spectacular scenery and an ideal location to experience training and professional growth. As always, the Conference provided the invaluable opportunity to become reacquainted with old friends and make new acquaintances. Many thanks to Sharon Shurow and her Conference Committee for their efforts in making the Conference such a success!

As a result of some changes and the outcome of the elections, we have a number of new members serving on Council this year. Active Participation Important For PASFAA

As chairman of the Government Relations Committee, it is my responsibility to see that PASFAA's voice is heard both on the state and federal levels. The Government Relations Committee along with the Legislative Network all work together to try to keep you informed of important issues.

However, your individual efforts are also needed! For example, when responding to a Notice of Proposed Rulemaking (NPRM), one letter representing the 500+ members of PASFAA carries no more weight than your individual letter addressing the same issue.

If the only comments sent to the Department of Education on NPRMs came from state and regional financial aid associations, only 58 (6 regional, 50 states, DC, and PR) letters would be submitted. On a recent NPRM the Department of Education wanted to see approximately 2,000 letters before they would reassess their position! Since there are 8,100 Stafford-eligible institutions, this would represent slightly less than a 25% response rate, not really all that high. But how many of you take the time to read and evaluate the proposed federal regulations that you receive and then sit down and write a response?

The next two years promise to be busy ones in Washington. With the ever present budget problems and reauthorization looming on the horizon, there will be plenty of activity to monitor. I certainly hope that I can count on all of you to become involved in state and federal issues. Please contact me at IUP if I can provide any insights or ideas on current legislation.



EASFAA Report

The EASFAA Council met on October 18-20 at San Juan, Puerto Rico, the proposed site of the 1992 conference. Committee reports included:

Training Committee is currently planning for an interactive, nuts and bolts workshop for late January or early February. This Workshop series will deal with such issues as refunds and repayments (have you figured it out yet?); FISAP preparation (the magical SEOG match); audit findings (how to reply/correct/change); FAT's (has anyone conquered them?); and office management and free for all (how do we keep this information under control?).

The Non-Traditional Concerns Committee, in conjunction with the Research Committee, has mailed out a survey to all institutions in the EASFAA region which have non-traditional programs. The purpose of this survey will be to determine what are the special needs of this group and how can EASFAA serve them?

The Conference Committee is busy planning the 1991 conference at Newport, Rhode Island, for May 5-8. In conjunction with this, the Minority Concerns Committee is planning a Financial Aid Fair to be held in Providence, in order to focus on inner city schools.

The Federal Relations committee prepared a response to the October 1 NPRM dealing with the conversion of clock hours to credit hours. Anyone who has responded to these two NPRM's is asked to send a copy of your response to Francine Andrea, University Director of Financial Aid, Drew University, 36 Madison Avenue, Madison, NJ 07940.

Three Ad-Hoc Committees (Central Office Organization, Long-Range Planning and Policy and Procedure Development) also reported on the status of their special projects.

The next EASFAA meeting is scheduled for January. Anyone who would like to bring an issue or question to EASFAA Council may do so by contacting Rachael Lohman, Wilkes University.

PAATP ANNOUNCES 1990-91

PAATP to hold workshops for Pennsylvania Business Officers

In February of 1991, the Pennsylvania Aid Administrators Training Program (PAATP) will conduct workshops for post-secondary institution business officers. Four workshops will be held throughout the state: February 19, 1991 at the Howard Johnsons Hotel in Monroeville; February 21, 1991 at the Penn Harris Inn and Convention Center in Camp Hill; February 27, 1991 at the Valley Forge Hilton in King of Prussia; and February 28, 1991 at the Days Inn in Meadville. The series will provide detailed information about the handling of student financial aid from the business officer's perspective.

Faculty will include experienced business officers as well as experienced financial aid officers. The agenda will include funds management, Stafford loan check processing, required record-keeping, refunds and repayments, reports, audits and program reviews, as well as updates at the federal and state level.

Brochures for the workshops will be sent to each Pennsylvania post-secondary institution's business office. Letters of invitation and brochures will also be sent to the financial aid office of each institution. While the workshop is geared to the needs of the business officer, it is hoped that financial aid officers might accompany their business officers to the workshops since attendance by both will further the cooperative working relationship necessary for institutional responsibility of student aid funds.

Financial Aid Institute for Financial Aid Administrators - A week-long workshop designed to provide a detailed exposure to student financial aid theory, regulations, policies and procedures for the neophyte aid administrator.

June 1991:

Financial Aid Institute for Student Loan Officers - An extended training session for student loan officers designed to provide a detailed exposure to the administration of student loan programs.







January 28 -February 1


We are preparing for PASFAA's sixth annual Financial Aid Hotline. The times, dates and places have all been set, but we still need you.


