Finally, I get to report on something that has happened in addition to things that might happen! On February 8, 2006, President Bush signed into law the Budget Reconciliation Act of 1965. Included in that Act is the Higher Education Reconciliation Act of 2005, which reduces spending on student loan programs by approximately \$12 billion over the next five years.

Just days before that signing, President Bush introduced his proposed Budget for the 2007 Federal Fiscal Year. That Budget lays out the President's plan to trim the federal deficit, primarily by cutting spending on domestic discretionary and

entitlement (mandatory) programs.

So as we move towards the 2006-07 academic year, we know some of what has happened, but we are still wondering what will happen next. Let me try to put all that in context for you.

Budget Reconciliation

In an effort to reduce federal spending on mandatory programs, Congress approved the Budget Reconciliation Act of 2005, which is projected to save approximately \$40 billion in mandatory spending over the next five years. The bill includes a number of provisions that impact the federal student loan program and the need analysis formula. These provisions include:

- Increasing freshman Stafford Loan limits to \$3,500, increasing sophomore Stafford Loan limits to \$4,500, and increasing graduate Unsubsidized Stafford Loan limits to \$10,000. All these increases are effective on July 1, 2007.
- Reducing student loan origination fees by 1% as of July 1, 2006 and a series of 0.5% decreases in those fees until the fees are eliminated as of July 1, 2010.
- Returning to fixed interest rates for Stafford loans (6.8%) and PLUS loans (8.5%) for new loans made on or after 7/1/06. The formula for determining the interest rates on Consolidation loans is unchanged.
- Making graduate and professional students eligible for PLUS loans under the same terms and conditions applicable to parent borrowers.
- Increasing the earnings allowance for dependent students to \$3,000, for sindle independent students and married independent students who are both attending school to \$6,050, and for other married independent students to \$9,700.
- Increasing the ways that students or families can qualify for an "auto-zero" EFC.
- Reinstating the exemptions for low-default rate schools from the delayed disbursement requirement for first-time borrowers and from the need to multiply disburse loans made for a single academic period.
- Placing a moratorium on new school lenders as of 4/1/06 and adding new requirements to school lenders.
- Creating a new program of "Academic Competitiveness Grants" of \$750 and \$1,300 to first- and second-year undergraduate students, respectively.
 - Creating a new program of "National

Science and Mathematics Access to Retain Talent (SMART) Grants" of \$4,000 for third- and fourth-year undergraduate students.

And, this is just the tip of the iceberg – a summary of the bill's provisions is available in the Government Relations section of the PASFAA website.

Reauthorization

So the natural question to ask at this point is, "Was this reauthorization or is there more to come?" There is not a definitive answer to that question. Clearly, this bill dealt with only a subset of items that usually make their way into a Higher Education Act Reauthorization bill – and only some of the items included in the House and Senate version of reauthorization. Most observers believe there is only a slim chance

that a full-fledged reauthorization bill will be approved by Congress this year. What we may see are bits and pieces of reauthorization appearing in other pieces of legislation – but those pieces would most probably be those deemed to be "non-controversial" in nature. It is unlikely that significant changes to the student aid programs would pass this test and be enacted into law. Thus, it may be that no more sweeping changes to the Higher Education Act are in store, at least in the short-term.

In the long-term, though, there is concern that another round of Budget Reconciliation could be in the offing. It will be difficult for that to occur this year in the limited time that this Congress has remaining – especially because they will be trying to get out of DC as soon as possible so that they can campaign for re-election. However, several senior members of Congress have been very public regarding their desire to enact further budget reductions. So, keep your eyes and ears open for developments on this front.

President's Budget Proposal

This brings us to President Bush's FY 2007 Budget request. While the Budget calls for a record \$2.77 trillion in federal spending, it proposes numerous cuts in domestic spending programs. Included in the budget are calls to eliminate the LEAP, Talent Search, and Upward Bound Programs and a proposal to require schools to remit the federal share of Perkins Loan collections directly to the Federal Treasury. Funding levels for federal student assistance programs would remain at current levels if the President's proposals are adopted including holding the maximum Pell Grant at \$4,050.

While many have characterized the President's Budget proposal as "dead on arrival," it does set the tone for this year's spending decisions. It is clear that with extra funds needed for military and homeland security programs and additional monies being demanded for the continuing efforts to recover from Hurricane Katrina and other natural disasters, this will be a lean year for other federal programs.

This means that it is more important than ever that we ensure that our Members of Congress and Senators understand how important student financial assistance is to our schools, students, and families. I encourage you to contact your representatives and make sure that they know the harm that could result if student aid funding is reduced. As new money becomes harder to find and the competition for scarce federal funds becomes more intense, we will need to work hard just to maintain current funding levels. This is not the time to sit back and expect that our allies in the Congress can support the programs we administer without our help.

"hot topics."

I left my position at Susquehanna University to accept a position at AES/PHEAA. The Financial Aid Awareness Committee met January 27 at AES/PHEAA. We accomplished many of our objectives as we head into the spring college fair season.



Rachael Lohman was darned difficult to pin down to do this interview – and that may be one of the most telling things about her personality.

Rachael is a very busy woman. Wilkes University has enjoyed a substantial spike in enrollment in the last year, and the challenge of meeting the needs of an unprecedented number of students has kept her and her office staff hopping. But that's not the real reason it was difficult to get Rachael to agree to sit down and talk. Despite the fact that Rachael is a bona fide Pennsylvania financial aid star – Past President of PASFAA, EASFAA, and past NASFAA Chair – Rachael is rather modest. She doesn't like talking about herself and her considerable accomplishments. And that is one of the many charming things about her.

Rachael was born in the foothills of the Pocono mountains – also known as Wilkes-Barre. She strayed once to the Big Apple, but then came home to stay. She received her B.S. in Business Education from Wilkes College and her M.Ed. from Bloomsburg University of Pennsylvania.

> Rachael's first professional position wasn't in financial aid – imagine that! She taught for two years at Wilkes Barre Business College and married David Lohman. The couple moved to New York City where Rachael worked as an administrative assistant in the real estate division of Kidder Peabody for a year.

> However, Wilkes-Barre Business College wooed the couple back home by offering Rachael her first taste of financial aid in the position of School Administrator in 1974. Lackawanna Junior College then bought the school, and Rachael stayed on for another 18 months as director of the Wilkes-Barre site. She was then promoted to Director of Student Affairs and Registrar for Lackawanna. She left there in 1980 and started at Wilkes College in 1981 as Director of Financial Aid, a position that she still enjoys 25 years later.

Rachael joined PASFAA as soon as she arrived at Wilkes. Her friends, Lucretia "Lucky" Hill at Keystone Junior College and Catherine Kratzer at Northampton County Area Community College encouraged her to become active. She started by serving on the 1984 Conference Committee at Pocono Hershey Hotel, chaired by Kratzer. Anyone who has served on a PASFAA conference committee knows how demanding the work can be, but it didn't turn her off! She actually served on the Conference Committee through 1988. Rachael was elected Treasurer in 1985, and back then, the treasurer served on Conference Committee. She was elected President in 1988 and served her term in 1989-1990.



Rachael doesn't believe her goals as President differed much from any of her predecessors. "I wanted to help all of us in the profession to do our jobs well by providing training and by working with policy makers to establish procedures to administrate programs that were reasonable and that benefited the students." She's most proud that during her term, PASFAA reached the first agreement with Pennsylvania's Office of Vocation Rehabilitation for standardization in reporting to them. Prior to 1989, regional offices of OVR asked for information various ways with the potential for students across the state to be treated differently. The standardization of this process meant that financial aid professionals could ensure

When asked, "What was the best thing about being President?" she just giggles that infectious Rachael giggle that everyone who knows her has come to love. "It was fun just working with everybody. The best thing about being President of PASFAA is the great people that you get to work with."

When asked how she believes participation in PASFAA helped her career, Rachael replies, "Volunteerism at the state level and the support that I received in everything that I attempted – whether it was training, conference committee, being treasurer, support from all around – all made it possible. The collegiality of everyone and their support helped me to gain the confidence necessary for me to move into the other roles. By volunteering you gain a knowledge base, then you go onto expand that knowledge base, and by gaining knowledge you also help the students at your school."

Loan Repayment Tips for Seniors Entering the "Real World"

According to the U.S. Department of Education's National Postsecondary Student Aid Study, student loan debt has almost doubled over the past decade, averaging approximate-ly \$19,300 per student. There are a few bright spots, however, for students going into loan repayment. Interest rates on student loans have been reasonably low and many lenders offer further reductions on rates for on-time payments and automatic debit programs. A variety of repayment alternatives are also available, including loan consolidation to help ease loan repayment and the interest may be tax deductible.

Here are some other tips for graduates to help ensure a worry-free repayment period: Avoid credit card debt and its high interest rates.

- Set a reasonable budget and stick to it.
- If economically possible, make payments on subsidized Stafford loans during the six-month grace period follow-ing graduation. Payments during the grace period are applied directly toward the principle, thereby lowering the
- amount of interest the borrower must pay during the life of the loan. Enroll in an automatic debit program. Some servicers offer borrowers an additional .25% interest rate savings when their loan payment is automatically debited from a savings or checking account.
- Make payments on time. This will save students interest, protect their credit and possibly qual-ify them for interest rate reduction programs, if their loan program offers it.
- Look for value added benefits such as the Upromise program where borrowers can have a percentage of their everyday purchases go towards saving for or paying back their student loan.

How to Pitch Ideas So People Will Listen

Do you ever wonder if people really listen to what you are saying? Most studies indicate that there are three common methods to effectively communicate - your delivery, audience involvement, and body language.

A good delivery needs to be clear and concise, grabbing the attention of your audience. It isn't so much what you say but how you say it. Involving your audience is another helpful tool to make the listener feel connected, engaged and a valuable part of the conversation or pres-entation. Body language acts very much in the same way as audience involvement. By focus-

ing upon the investment of your audience and engaging them in the idea that what you are saying can somehow improve their life will enhance their responsiveness and body language. Understanding and reading your audience's body language allows you to determine if they are interested and comprehending your message. Their posture, eye contact, mannerisms and participation will express whether they are buying into your message or not.

Another critical component is to emotionally invest your audience. Emotional investment results from providing your audience with an improvement to their lives on either a short term or long term basis. A short term emotional investment could be something as simple as improving workflow. Emotional investment on a long term basis might be a joint relationship between two companies. Whether the relationship is short or long term, the end result is an improved emotional benefit between all parties. People are always look-ing for ways to solve their problems, improve their current situation and make their lives more productive and less stressful. Be prepared to answer the listener's question of "What's in it for me?





To hold your listeners' interest, base your delivery on emotional investment and not so much specific content but rather the principal of improving the lives of your audience. Providing too many details will bog down your idea. For example, if you are trying to sell a car to a potential buyer, you won't want to tell them about every bell and whistle the car has to offer. Simply state the key points about the car and how the car is going to improve their commute or cause less has-sles than their previous car. Too many details can kill your listener's interest.

By emotionally investing the audience in the presentation, you are naturally creating audience involvement. If the listener feels they are disconnected from the situation, they will have no feel-

ing either way about the topic and will walk away with nothing. For example, if you are fundraising and need to get donors, you would want to express how much better the potential giver will feel about themselves by making a contribution and supporting a cause. Everyone deep down inside wants to feel like they are making a difference by helping others.

Audiovisuals are helpful, but slick Powerpoint presentations and glossy handouts won't hold your audience's attention for long if they don't feel emotionally connected to what you are saying. By tuning into your listener's emotions and maintaining a focus on the well-being of your listener, you will have created a captive audience. Emotional investment is the key to making a connection to your audience and having them more receptive and agreeable to your ideas.

A Day in the Life of a Customer Service Representative

Similar to old folk lore passed down from generation to generation, borrower repayment stories spring up from time to time, detailing the most amazing circumstances. They spread through the call center like rumors in high school with

As the saying goes, "Variety is the spice of life." Observe any student loan customer service representative in one day, and you'll realize that no two tasks are the same. They are our front lines – the folks who work to support borrowers through their repayment years. A typical day would certainly include processing a payment over the phone or consulting a borrower on the various repayment options. But as we all very well know, days in the student loan industry are far from typical.

One such story surfaced of a doctor who insisted upon skydiving into the servicer's parking lot to personally deliver his final student loan payment. He even called the local airport to hire a pilot to help him make the jump. After many months of discouraging the doctor, the customer service rep was finally able to convince him not to risk his life for a payment. So instead, the doctor resort-

ed to riding his motorcycle from Connecticut all the way down to Pennsylvania. He arrived at the center in full leather apparel and motorcycle gear to meet his representative and write his final check.

If you ask a service representative what they enjoy most about their job, they will tell you it's the feeling they get when helping a borrower who is truly in need. As we all know, there can be many challenges and unforeseen obstacles when leaving college and entering into repayment. The customer service representative always looks to excel in supporting the borrower with whatever issues are preventing them from managing their student loan debt.

Take, for instance, a borrower who decided to live in a remote, wooded area in order to study for the Bar exam. No phone, no TV, no computer and no mail delivery service – just his books and himself. With a 40-minute drive down a mountain to reach the nearest post office, it was no surprise that his past due bills never made it to their final destination. He was a 21st century lawyer living in a place where time

stood still. Being removed from on-line access and electronic processes, specialized support was required. When he was finally able to connect with the borrower call center, it was only a matter of time before the deferment was processed and the borrower could free himself of the "monthly mountain drive." He was now free to concentrate on more important things like his studies.

Whether funny or serious, every customer connection reinforces to the representatives the importance of making each customer their number one priority. One story, in particular,

affirms this point. A borrower called to request a Total and Permanent Disability Discharge for his loans. He explained his condition and reasoning behind his request. However, assuming that the representative did not believe him, the customer became very defensive, attempting to convince the representative that he wasn't lying. The experienced representative waited until the borrower calmed down and then explained to the customer that he could relate to the situation, because his father suffered from the same condition. Once the borrower had gained trust in the representative, the representative was able to assist the borrower and send his request to the Department of Education for a three-year conditional discharge period. The borrower expressed many times how much he appreciated the representative's help.

Every communication with a customer is unique, and a representative's job is to determine how best to handle each situation, whether that means on the phone or within the service center. Most importantly, though, a customer service representative must listen intently to every customer's needs and respond appropriately. From the examples above, it is clear that a representative's role is vital to keeping customers happy and building lasting relationships with them. And, besides, without customer service representatives, who would prevent borrowers from skydiving?

Financial Literacy

Financial literacy has been coming more and more in vogue as public policy leaders focus on globalization and its impact on finance and investment with individuals more empowered than ever. With savings rates in the United States lower than in other countries and the emergence of electronic cash while printed/minted currency becomes more of the past, the need to focus on financial literacy is more critical than ever. Some members of Congress have been focusing on this issue as a by-product of the debate on the reauthorization of the Higher Education Act, and indeed, one of the bills put forth for consideration in the reauthorization process contemplated the development of a program. The concept of financial literacy is being given greater attention as part of student aid administration and as

eracy is being given greater attention as part of student aid administration and as part of early awareness programs as well.

As financial aid has morphed into paradigms such as student financial services – with the field no longer just a place for scholarships, grants, and loans – financial literacy may be the next big trend. Consider the regulatory requirement for entrance and exit counseling for borrowers of Federal Stafford Loans and Federal Perkins Loans. Plus, the controversy of credit card and financial services firms having unrestricted access to campuses has highlighted the need as well. And like it or not, the debate which emanated from Congressman McKeon's comments about the rising costs of college has placed this issue as a marker within the context of the policy debate on higher education subsidies.

Some schools have adopted freshman seminars to educate new students about the need to manage money while in school. Many firms in the finance industry have also developed tailored resources aimed at students to educate about the need for financial literacy. In some cases, such firms have developed relationships, as part of their lender partnerships with schools, to develop tailored programming along these lines.


A new book addresses the issue head on. In Financial Basics: A Money Management Guide for Students (The Ohio State University Press, 2004), author Susan Knox (a CPA and former university administrator) puts forth an intelligent-

ly presented primer on all sorts of financial related matters to help the college student who may be "on their own" for the first time. Knox covers topics as simple as how to write a check and balance a checkbook, developing and analyzing a monthly and annual budget, overcoming the "seduction" of credit cards, and the development of a credit history. The chapter "First in the Family" outlines financial aid

and the kinds of student aid available to pursue, but the discussion is not especially detailed in that annual and aggregate loan limits is not mentioned, nor is there any discussion of alternative loans. In "How Much Did You Say I Owed?," Knox addresses debt management issues we are familiar with from entrance and exit counseling responsibilities. Knox's book is an excellent publication that could serve a very useful purpose for those in the student aid business to develop intelligent approaches to the promotion of financial literacy.

There are other resources available as well. The National Endowment for Financial Education (NEFE) has developed an excellent program aimed at high school students, the "High School Financial Planning Program." The materials for the program can be downloaded from their web-site, http://www.nefe.org/pages/educational.htlm. The strength of the NEFE offering comes from its web-based training program.

A similar program has been developed by the Jump\$tart Coalition for Personal Financial Literacy, which they call "Financial Smarts for Students." See http://www.jumpstart.org.

PHEAA Funds Boost State Grant Awards

PHEAA announced that the purchasing power of the average State Grant award will see an unprecedented increase of \$490 as a result of the funding provided by PHEAA for the 2006-07 academic year bringing the average award up to \$3,035. PHEAA will supplement the program with a total of \$72.5 million in additional grant funding without any taxpayer support.

This increase in State Grand funding is the direct result of two recent PHEAA initiatives. The PHEAA Board of Directors established the State Grant Task Force, under the leadership of Representative Jess Stairs, which evaluated the purchasing power of the State Grant Program. Following numerous public hearings and exhaustive research and evaluation, the Task Force proposed a new State Grant awarding formula, which was accepted by the Board of Directors.



In addition, PHEAA is providing \$25 million of its earnings to directly supplement the State Grant Program during the 2005-06 academic year. This is an addition to the \$15 million that PHEAA spends annually to administer the program on behalf of the Commonwealth. PHEAA's administration of

the program ensures that every appropriated dollar goes directly to students.

"There was no doubt that the effectiveness of the Pennsylvania State Grant Program in meeting students' financial need was headed downward," said Representative Elinor Z. Taylor, chairman of the PHEAA Board of Directors. With the funds contributed by PHEAA, we are able to revitalize the program and increase the average State Grant award for next year by \$490 for the nearly 172,000 anticipated recipients."

From the Editor's Desk


