EXECUTIVE COUNCIL NOTES

Council last met on June 1, 1987 at PHEAA in Harrisburg. A few highlights of the meeting are as follows:

Committee participation for 1987–88. PASFAA Members interested in serving on a committee for 1987–88 should complete the form that is located elsewhere in this newsletter. Committees will then be able to begin work at the conference or soon thereafter. Get involved—you'll be glad you did!

Absentee Balloting. PASFAA members will be voting on this issue at the 1987 conference in October. If passed by the membership, absentee balloting will be available for 1988-89. See the article elsewhere in this newsletter for details.

PAATP News. Council approved five people for submission to PAATP to serve on the Planning and Program Development Committee. These five people were Kate Hetherington, Betty Davis, Rick Wilson, Mary Miller and Catherine Kratzer.

1988 Conference. Council unanimously approved the Hershey Hotel as the 1988 conference site. Michael Schreier, Northampton County Area Community College, is the conference chairperson.

Council's next and final meeting will be held at the conference in October. Please contact any council member with matters of interest before the conference.

MEMBERSHIP WILL VOTE ON ABSENTEE BALLOTING ISSUE

PASFAA Council has considered a procedure which, if approved by the active members, would allow PASFAA members who are unable to attend an annual conference to vote for council members by absentee ballot. Approved by Council at its June meeting, the following proposal will be presented during the business meeting at the 1987 Conference in Seven Springs. If the By-Laws are revised by vote of the active members, absentee balloting would begin for the 1988 election of council members.

ELECTION PROCEDURES

- I. Nominations would proceed unchanged as follows:
 - A. A mailing to all active members in June solicits nominations.
 - B. The slate of nominees is presented to the membership in the August edition of the Newsletter.
- II. The balloting procedures would be described in the August edition of the Newsletter as follows:
 - A. Regular Balloting: Instructions for regular balloting during the annual conference would remain unchanged.
 - B. Absentee Balloting: An absentee ballot will be sent to any bona fide active PASFAA member whose membership dues for the next fiscal year are paid in full and who is unable to attend the annual conference. A written request for a ballot must be received by the chairman of the Membership and Elections Committee by September 1. Com-

NASFAA CONFERENCE WEATHERS BLISTERING HEAT

Nearly 1,400 aid officers from throughout the country gathered July 22–25 in Washington D.C.'s blistering 95+ degree heat for the 13th annual NASFAA Conference. More than 50 Pennsylvanians joined in for general sessions which included congressional and department of education spokesmen as well as concurrent interest sessions ranging from all aspects of reauthorization to philosophical discussions of financial aid

Bill Burke, legislative network coordinator, organized the Pennsylvania congressional visits for July 23 which included scheduled meetings with 20 of the 23 congressional representatives and with Senator Heinz. Many PASFAA members reported worthwhile discussions on topics including the effects of reauthorization, need for federal appropriations for programs, and the paperwork burdens of recent regulations. NASFAA President Dallas Martin particularly urged members to seek appropriation support for the student financial aid program funding included in the federal budget.

Some of the important, factual information received at the onference appears below. Several of the items will require attention and encouragement by aid officers for support and assistance by members of Congress.

House Bill H.R. 2649, The Lancaster/Price/Kennedy Higher Education Bill would correct some inadequacies passed in last year's
 Tax Reform Act. This bill would restore the deduction for interest paid on educational loans and would reinstate the fully tax-exempt status of scholarship funds. The bill's sponsors addressed NASFAA

members during the conference urging support for their bill. As of the time of the conference, 37 house members were reported supporting the bill. As a result of their congressional visits, some PASFAA members report that their representatives have signed on to support the bill.

Conference attendees were reminded by the Department of Education that students enrolled in teacher certification programs and students coming early to post-secondary schools while still completing high school are not eligible for federal aid. These are two pieces of fall-out from reauthorization which dictated that students must be enrolled in degree or certificate programs and that students cannot be simultaneously enrolled in elementary/secondary and post-secondary schools.

It is understood that these two specifics are "interpretations" of the law by the Department. It is hard to believe that the intent of Congress would be to discourage those preparing for teaching careers and some of the brightest among our population. Certainly the law was aiming at preventing people from receiving Title IV aid for what could be termed "frivolous" study outside of degree or certificate programs. While those enrolled in teacher certificate programs do receive that document at the end of their program, it is usually awarded by the state and not the educational institution.

At a time when Congress is encouraging people with scholarships to go into teaching to meet a societal need, it seems inappropriate that they now be prevented from eligibility for student loans under reauthorization. Many of the students who enroll simultaneously to complete their senior high school year and begin post-secondary study are among the brightest and most motivated.

***** NOMINATIONS FOR 1987 ELECTION

A slate of nominees for the October PASFAA election has been prepared by the Membership and Elections Committee. Nomination forms received by the August 4 deadline were used to prepare the list of candidates. The two people with the most nominations for each open council position are presented below and will be entered on the ballots to be cast at the annual conference in Seven Springs. The names of additional candidates may be added to the two identified for each position by the Committee by nomination from the floor of the annual business

This year each voting member may vote for a candidate for President Elect and a candidate to represent his or her sector on the PASFAA Council.

Although PASFAA Council has recommended the adoption of an absentee balloting procedure (described on page 2 of this Newsletter), such a procedure is not available as an alternative to the traditional voting method for the October, 1987 election. A change in the By-Laws of the Association is required to enable absentee voting.

Active members, described as financial aid administrators at educational institutions, are the only PASFAA members eligible to vote. Ballots will be distributed to active members in their conference packets, and the double envelope systems of balloting will be used.

After the first session of the annual business meeting when additional nominations can be made, a ballot box will be located near the registration area of the hotel to receive completed ballots. The box will be available during the times when members of the Conference Committee are working at the registration tables. Ballots may be cast until 12:00 noon on Tuesday, October 13 and the Membership and Elections Committee will announce election results during the second session of the business meeting.

It is unclear if Congress is aware of these two interpretations by the Department, PASFAA members are encouraged to inform their congressional representatives and key members of educational committees on these matters.

The INS regulations requiring all new employees to submit documentation for the I-9 form will prove to be particularly burdensome to post-secondary institutions which hire student employees. Currently, part-time student employees are not exempt from these requirements.

PASFAA members are encouraged to inform their congressional representatives of the burdensome nature of these requirements on

schools and colleges. Many institutions hire hundreds, and in some cases, thousands of students, in a few days early in the semester to begin work immediately. The INS regulations require that the paperwork be completed within 3 days of the employee beginning work. It is likely that in writing the law Congress did not take into account the millions of student employees affected.

It is unlikely that illegal aliens, at whom the law is aimed, are attempting to be employed part-time on college campuses while enrolled as students. You are urged to encourage your congressional representatives to waive students working on their campuses from these INS requirements. Not only is the regulation burdensome to the school administration; it may also inhibit and delay delivery of student aid to deserving students and eligible citizens.



"NEW" SATISFACTORY PROGRESS GUIDELINES

The Higher Education Amendments of 1986 brought many "new" changes to the processing of federal financial aid for both "new" students and currently enrolled students. To name a few changes, aid offices were challenged with "new" independent student definitions, the "new" GSL need analysis, and the "new" GSL loan limits. There is also the "new" loan consolidation program and the "new" loan disclosures. Because many of these changes went into effect January 1, 1987—they of course are no longer "new"; they are being practiced nationwide by all aid officers. However...the "newest" one, which many aid officers probably decided to worry about later, is the "new" satis-

factory progress definition, which is effective for periods of enrollment beginning on or after July 1, 1987 to individuals who have not been previously awarded Title IV assistance, i.e., "new" freshmen are affected. This definition states: a student is making satisfactory academic progress if, at the end of his or her second academic year, he or she has a cumulative "C" average or better. This "new" definition is in addition to a school's existing progress definition for currently enrolled students who have already received aid under a Title IV program. This means that schools will now have two satisfactory progress definitions—one for "new" students or first time aid recipients, and one for old students.

The complete, new definition can be found on page 6 of the October 8, 1987 PHEAA update memo and page 1.11-37 of the NASFAA encyclopedia. Also, aid officers will need to create a "new" Financial Aid Transcript which will state the dates a student received aid at your institution.




PASFAA '87 KEYNOTE SPEAKER: LIEUTENANT GOVERNOR MARK S. SINGEL

Mark S. Singel served as an aide to U.S. Representatives Helen S. Meyner (D-NJ) and Peter A. Peyser (D-NY) from 1975 through 1979. Singel was elected to the 35th District seat in the Pennsylvania Senate in November, 1980—one of the youngest members ever elected to the state Senate, and was reelected in 1984. He served for six years as a state senator specializing in legislation relating to economic development, education, and local government.

In May, 1986, Singel won a hard-fought primary to capture the Democratic nomination for Lieutenant Governor over two opponents. On the ticket with Governor Robert P. Casey, Singel—at age 33—won the 1986 November general election to become the 27th Lieutenant Governor of the Commonwealth of Pennsylvania.

In addition to his Constitutionally assigned duties of President of the Senate and Chairman of the Board of Pardons, Singel serves—by appointment of the Governor—as Chairman of the Governor's Energy Council, Chairman of the Pennsylvania Emergency Management Agency and Council, Chairman of the Emergency Response Commission, member of the Economic Development Partnership Board and Governor's representative to the Penn State Board of Trustees.

pleted absentee ballots must be received by the chairman prior to one week before the official opening day of the annual conference to be considered valid.

Those requesting absentee ballots will not be issued regular ballots at the annual meeting and will be denied the opportunity to vote for any person nominated for PASFAA office from the floor of the annual business meeting.

All bona fide absentee ballots for each PASFAA office will be opened and counted by the Membership and Elections Committee members prior to the counting of regular ballots. Absentee ballots carry the same weight and influence as regular ballots.

BY-LAWS REVISION

Amendments to the By-Laws are achieved by a two-thirds majority of members voting; provided that certain notifications are made and that the proposed amendment is mailed to active members at least thirty days before the vote is called by the Council. Therefore, it is recommended that the by-laws revision mechanism be activated to achieve the following change:

By-Laws, Article II, Section 2

The current statement:

Election of officers and Councilpersons shall be held under the

supervision of the Membership and Elections Committee and shall take place at the Annual Conference of the Association. Election shall be by plurality of Active members present and voting. No write-in vote will be counted unless the person receiving the vote has been nominated by the assembly. Voting shall be by the double envelope method of secret balloting.

The proposed revision:

Election of officers and councilpersons shall be held under the supervision of the Membership and Elections Committee and shall be by plurality of active members voting. Balloting shall be conducted as follows:

- a. Regular Balloting—shall take place at the annual conference of the Association. No write-in vote will be counted unless the person receiving the vote has been nominated by the assembly. Voting shall be by the double envelope method of secret balloting.
- b. Absentee Balloting—is available to bona fide active members whose membership dues for the next fiscal year are paid in full and who are unable to attend the annual conference. An absentee ballot must be requested of the Chairman of the Membership and Elections Committee in writing by September 1 and completed and returned to the Chairman prior to one week before the official opening day of the annual conference. Those requesting absentee ballots will not be issued regular ballots at the annual conference and will be denied the opportunity to vote for any person nominated for office from the floor of the annual business meeting. Absentee ballots will have the same weight and influence as regular ballots. No write-in votes will be counted. Voting shall be by the double envelope method of secret balloting.

PACU PROJECT COMPLETES FIRST YEAR

Project for an Informed Choice sponsored by the Pennsylvania Association of Colleges and Universities has completed its first year of operation. The project's purpose is to stimulate college going rates among high school graduates. Despite the declining 18–22 year old population, the Project is making progress in increasing participation rates. The following excerpts are from a report describing what PACU has accomplished thus far in achieving the objectives of the Project and a description of remaining objectives to be accomplished.

- 1. **OBJECTIVE:** TO IDENTIFY THE PARTICIPATION SPINOFF PROGRAMS INITIATED ACROSS THE STATE AS A RESULT OF THE 1987 PACU STUDY. (Only selected, significant undertakings are referenced in this report.)
- Four Northampton County institutions produced a 30 minute color video tape and accompanying brochures to be used with school students and parents as a means of raising the awareness levels of students and parents about participation in postsecondary education.
- A "Collaborative for West Philadelphia Publick Schools" has been established to include tutoring, having college presidents visit schools, and
 preparing an educational guide listing the resources of the community.
- The Harrisburg Area Community College has assigned an admissions representative to high schools within the region to increase awareness of
 the opportunities available at the college.
- Kutziown University busses minority high school students throughout their service area to the campus for presentations by various staff members.
- The University of Pittsburgh at Bradford hosted a Career Day for eighth grade students and their parents.
- Metropolitan Pittsburgh Public Broadcasting, Inc., in partnership with the Pittsburgh Council on Higher Education and the Pittsburgh Urban League, is producing a special television program titled "Minorities in Higher Education."
- The Pennsylvania Gas Association is expanding a formerly regional publication called "Family Guide to College Costs" to embrace the entire Commonwealth.
- Pennsylvania Association of College Admissions Counselors (PACAC) has produced two public service announcements and is working on a third for use on television and radio across the state.
- PHEAA has developed the PHEAA Aid Information System (PAIS) to allow students and parents to estimate their eligibility for aid programs.

In an effort to learn more about major undertakings as well as "grass roots" activities, PACU recently placed articles in newsletters of seven school and college education associations, asking people in basic and higher education what they have been doing to stimulate interest in, and give greater attention to, career exploration and educational planning among parents and students and to raise their awareness levels of the opportunities available for participating in postsecondary education. We want them to send their ideas to us.

Our long range goal is to take all the ideas which we receive, publish the best of them in a soft cover sampler, and distribute them to schools, colleges, and communities. This sampler will serve as an idea reference guide that may be helpful to persons and organizations interested in bringing about changes in the educational processes of students.

- 2. **OBJECTIVE:** TO SERVE ALL PARTICIPATION ACTIVITIES, OPERATIONALLY AND PROGRAMMATICALLY, FROM THE CENTRAL OFFICE IN HARRISBURG.
- In the PDE campaign encouraging "Parents, Be a Part of It," a workshop was held at Shippensburg University last fall for school administrators, counselors, and home school visitors to assist them in implementing the "Parents, Be a Part of It" program.
- PACU and PDE have held several meetings to discuss a program intended to communicate to parents of eighth and ninth grade students with information about the value of a college education and the opportunities available in Pennsylvania colleges and universities.
- PHEAA and PACU cooperated to send personal copies of "Choices, A Guide to Pennsylvania Colleges and Universities" to 516 black clergy throughout the Commonwealth with the intent that the guide would prove helpful to minority group students, and those who guide and counsel them, in making the decision to attend a college or university in Pennsylvania.
- PACU, PHEAA, and PACAC have discussed the possibility of coordinating sponsorship of postsecondary education and financial aid information booths at selected shows, fairs, and special events programs.
- PACU has applied for and received permission to give workshop presentations at the Pennsylvania School Counselors Association (PSCA) and PACAC conferences this spring and summer.
- The Department of Education continues to advocate the concept of Partnerships in Education. These partnerships are voluntary, formal arrangements between schools and public and private sector groups, which are designed to combine the energies and resources of the partners to enrich various aspects of the educational process.
- PACU has held meetings with representatives of PACAC to encourage them to pursue their plans for producing public service announcements promoting higher education in the state.
