The Northwest Pennsylvania Financial Aid Administrator Association (NWPFAA) awarded three \$300 scholarships this fall to students attending member institutions. Well over one hundred and fifty applications were received from incoming first year students. Awards are made in three categories: Four year, two year or less and combined (either two or four year). Scholarship recipients will be attending Crawford County AVTS (practical Nursing Program), Westminster College and Clarion University of PA.

NWPFAA is composed of approximately 52 member institutions including financial aid administrators, student loan officers, guidance counselors and other professionals who interact with the financial aid community. The group, which has been in existence for five years,

generally meets twice a year in an effort to provide an informal forum for the various constituents to discuss aid issues. Frequently, guest speakers from a variety of different fields are asked to speak to the members on a variety of different issues such as debt management and advice on financial investments.

NWPFAA members hope that their organization will continue to grow so that they may award scholarships to eligible students in the future. Plans are already underway for the organization's Spring meeting. ### Financial Aid Nights:

Imagine this scenario, if you will: it's six o'clock in the evening on a rainy Monday night. Daylight savings time has long since passed, so it's pitch black when you leave the office. You have butterflies in your stomach because you have little experience in public speaking. You're nervous about representing your institution because you must concern yourself with its reputation as well as your own, and you can forget about dinner. There's no time to eat, and you're too queasy anyway. Rush-hour traffic has reached an all-time high and you're anxious about arriving late. You think wistfully about being cozy at home with your family, perhaps watching the evening news. At this point, you wonder just how you've gotten into this mess. Is it really worth it? Absolutely.

Participation in local Financial Aid Nights can be rewarding for the individual as well as for the institution he or she is representing. It is a goodwill gesture that can provide generous returns for all, whether you are a Financial Aid officer or lender:

• Appearances at Financial Aid Nights can boost sagging enrollments and increase loan volume. No, there's no empirical data that can support this claim. However, the college or bank that has a "presence" in the marketplace can only benefit from good public relations . . . and that's exactly what a good speaker can do for his employer. For instance, if a student was torn between ABC and XYZ Universities, hearing a convincing presentation by a caring professional might make the difference. It certainly couldn't hurt.

From the lender's perspective, I have received numerous phone calls over the years from parents who have heard me speak and were not PNC Bank customers at the time. We've not only made loans to those families, we've also captured some of those deposits!

- Financial Aid Nights can play a significant part in your comprehensive community outreach. Every institution is concerned about its public image to some degree. What does the college do for the town in which it's located? What does the bank do for the city? Your volunteering of your time as a designated representative of your employer can only enhance its status in the community. This is particularly important for financial institutions in compliance with Community Reinvestment Act (CRA). Lenders should let their CRA Officer know when they're speaking publicly. If your institution isn't large enough to have a specific CRA department, contact your Compliance Officer. It's guaranteed that someone in your shop will want to know of your efforts.
- The Un-wrinkled brow phenomenon: The professionals in financial aid and student loans tend to be a pretty caring group. There is a tangible reward in dispelling parents' concern. They arrive at the high school visibly worried about how they're going to pay for their child's education. Most of them don't even know where to start. You can't solve all their problems with a general presentation in one night, but you can educate them as to what their options are. As the old adage goes, Knowledge is Power, and they leave feeling better equipped to deal with the overwhelming task of financing an education. It's especially rewarding when someone approaches you after



























the lecture portion to thank you, or to ask you a question privately. That gratitude outweighs your early evening butterflies-in-the-stomach.

#### ... And now, for some pointers ...

- KNOW YOUR TOPIC. That seems pretty self-evident, but take another look. Are you a generalist, or do you specialize in a particular area? FAO's: when's the last time you reviewed which states are non-portable for the PHEAA State Grant or what the out-of-state limits are? Lenders: are you familiar with the new Common PLUS app? Are you up-to-date on how PLUS loan denials may result in the awarding of an Additional Unsubsidized Stafford loan to the student?
- Find out who the other speakers will be that evening. If you're new to this business, the Financial Aid Officer and/or PHEAA Regional Director will be placed on the agenda before the lender. However, you should coordinate with the other speakers to minimize duplication of effort. Too much repetition is boring to the audience, and potentially annoying to your colleagues. Know in advance if you're willing to share the podium with a financial planner, or how many speakers is your (or the audience's) limit.
- Bring some materials with you. Whether it's an institutional aid or bank student loan brochure, your own fancy publication, or The Student Guide, it's always helpful to bring supplementary material to have parents take home. Learn from the Guidance Counselor how many have attended in the past so you can gauge how many to bring.
- Of particular interest to lenders: be sure to brush up on direct loans. Be prepared. You should know the extent of national and state involvement in this program and be ready to discuss it calmly and professionally. Direct loans have received some press outside of the aid community, and parents are confused. You can help clarify, or ask your FAO partner to assist you.
- Other ways to enhance your presentation: Consider taking a public speaking course if you feel you need it. Perhaps your institution has a course in its training department. Visual aids always assist in making a clearer presentation, too. This could range from a showy slide presentation to running transparencies through the office printer. The audience will be grateful you invested the time to do so, even if they're unaware of it.

You can enhance both your institution's and your own professional image in the successful planning and implementation of a good Financial Aid Night program. Best of Luck!

#### PASFAA EXECUTIVE COUNCIL MINUTES OCTOBER 26, 1994

- The PASFAA Executive Council meeting was held on October 26, 1994 at 7:45 am in the Circular Dining Room of the Hotel Hershey, Hershey, PA.
- Madelyn Campbell reported that Robin Szitas passed the year end reports to the auditors. She also reported that we will continue to use the same auditor as last year.
- New expense reports will be made up indicating Madelyn Campbell as the new Treasurer. Madelyn also reminded Council that she needs expense reports for all receipts submitted.
- PASFAA must pay sales tax on all items so Madelyn reminded members of this when working with outside vendors.
- Marge Karl moved to accept the Financial Statement that was presented and Cate McIntyre seconded the motion. Motion approved.
- Clarke Paine reported that at least 425 paid attendees were present at the conference, however, this is not a final count.
- Chris Zuzack commended the conference committee on an excellent job.
- Georgia Prell made a recommendation and the recommendations was approved to appoint Fran McKeown as the 1996 Conference Chair.
- The 1995 Conference will be held October 22-25, 1995 at Seven Springs Resort.
- The 1995 Conference committee was approved: Jim Zuzack, Julie Salem, Joanne Parke Davidson, Michael Price, Patrick Hayes, Fran McKeown.

- 38 sites have been selected for the 1994 Guidance Counselor Workshops with all the workshops being held in November. All materials have been revised to fit the revised format.
- Extra transparency materials are available to the membership. A report will be in the membership to advise members that copies are still available.
- Alisa DeStefano was presented and accepted as a new member of the Editorial Board of the PASFAA Newsletter.
- Georgia Prell will continue to serve on PAATP. And Cindy Heaton will fill Georgia's unexpired term.

A sector meeting will be held in Harrisburg on November 10-11, 1994



#### TRAINING: KEY TO SUCCESS & PROFESSIONAL DEVELOPMENT - Part 2

To become a PAATP volunteer is as easy as 1 - 2 - 3! PAATP mails an announcement in January inviting individuals from the financial aid community to volunteer for the next program year; this announcement is both an invitation to participate and an application form. This year's mailing will be different since both the PASFAA self-nomination form requesting that individuals with training experience volunteer to be considered for appointment to the Planning & Program Development Committee and the PAATP interaction/application form will be in the same envelope. The PPD&C is the committee which plans the calendar of workshops to be presented during the program year. Volunteering for PAAPT may include serving as a committee member which involves writing assignments or as both committee and faculty which involves writing assignments and presenting for a workshop series. The completed PAATP application is to be returned to PHEAA; the self-nomination form should be returned to PASFAA.

Each July PAATP mails acceptance letters along with a personnel data sheet to its volunteers with all of the pertinent information concerning the workshop series, meeting dates, the schedule workshop dates, etc. to which they have been assigned.


Are there advantages resulting from being a PAATP volunteer? We can only share what your colleagues have said over the years. Several individuals have expressed that it gave them the opportunity to meet and work with individuals at other types of institutions as well as from different parts of the state. It also provides you with recognition from your peers and from your institutions that you are a dedicated professional willing to share experiences and information with the financial aid community. Training opportunities are available and you will be able to "grow" within your profession as a presenter as well as learn while being part of the training process.


The Planning and Program Development Committee reviews the list of volunteers and their applications that were received during February and March. The volunteers are assigned as committee or committee/faculty to each workshop series with consideration of both experience and region. Based upon acceptance of assignments, individuals are contacted until all of the workshop series for the new program year are completely staffed. By returning the personnel data sheet and accepting an assignment to either write a portion of the syllabus or both write and present, the volunteer has committed oneself to giving of his/her time and talents to PAATP. This acceptance should not be taken lightly, it is a major professional responsibility to help in providing current training information to your colleagues and other professionals in the financial aid community. A committee/faculty member is expected to complete the assignment given to them by their chairperson in a timely manner and to the best of their ability.

Membership on the Planning & Program Development Committee is a three year commitment of five meeting a year along with the chairmanship of a workshop series which will require an additional two meetings in Harrisburg and/or at a workshop.


