The Calm Before the Storm

As you will note, this version of my quarterly federal update is a bit shorter than usual. That is because the U.S. Congress has been a bit short on action these days, especially with regard to the student aid programs.

Just to review the bidding:

Congress has completed work on the FY 2011 budget, allowing the Department of Education to finalize the Pell Grant payment schedule, based on a \$5,550 maximum Pell Grant, and provide schools with their Campus Based funding allocations for the 2011-12 academic year.

That leaves Congress with two hurdles to clear before we will know those numbers for the 2012-13 academic year. First, Congress must deal, one way or another, with the impending breach of the government's debt ceiling (i.e., the Treasury Department's borrowing limit). While conventional wisdom was that the debt ceiling would be reached right around now, some fiscal sleight of hand has stretched that date out to August 2nd - coincidentally, just prior to the start of Congress's summer recess. It is very clear that an increase in the debt ceiling must be tied to some serious spending reductions in order to win Congressional approval. It is expected that a package of cuts of more than \$1 trillion over a five or 10 year period will be required to round up the needed votes. Talks to develop this package are being led by Vice President Joe Biden. Almost every aspect of federal spending, with the exception of Social Security, seems to be on the table and subject to reductions. No details, however, have emerged as of yet from these discussions.

The second hurdle will be the FY 2012 federal budget (the budget that begins October 1, 2011 and funds student aid for the 2012-13 academic year). There has been some preliminary work on FY 2012, including the passage of a House budget plan drafted by Budget Committee Chairman Paul Ryan (D, WI) This package has gained particular notoriety for its proposal to reengineer Medicare, but also included some serious cuts to the Pell Grant and other student aid programs. However, the real work on setting funding levels for individual programs for FY 2012 is not likely to get underway until the debt ceiling issue is resolved.

Thus, as I indicated above, there is little in the way of concrete information to report.

This lull in Congressional action presents an opportunity for you to remind your Members of Congress and Senators

of the importance of the Pell Grant and other student aid programs, not to mention TRIO and GearUp. We know, for example, that the President's proposal to curtail interest subsidies on Stafford Loans for graduate students is being considered seriously and there is even talk of expanding it to undergraduate students. We also know that the Pell Grant Program is going to face increased pressure as it continues to be plagued by funding shortfalls due to increasing demand. Funding for all these programs will be competing with hundreds of other federal programs and interests for slices of a shrinking federal pie. If we do not make our case to Congress, we risk being perceived as a constituency that can be pushed aside in favor of others who are more vocalyes, sometimes the squeaky wheel does get the grease.

Looking back at the most recent few months, we all have experienced significant regulatory and legislative changes which will impact us, our colleges and universities, and our students now and in many years to come. The drivers of these changes, at the institutional state and federal levels are: transparency, accountability, and fiscal responsiveness to address budget deficits, to insure that we continue to provide a quality educational experience. It is a continuous reminder of the plethora of changes which financial aid professionals have experienced in the past 4 years, (7 packages of new regulations) and the continuous responsiveness and adaptability required of all financial aid professionals:

A brief summary of the most significant changes are:

- 1. The passage of the Department of Defense and Full Year Continuing Appropriations Act 2011 (P.L.112-10) enacted on April 15, 2011:
 - a. Funds federal government through the remainder of the fiscal year.
 - b. The maximum Pell Grant of \$5550 was preserved.
 - c. The crossover regulation was lifted for the Summer 2011 period.
 - d. FSEOG was cut by \$20M.
 - e. .2% cut to all other ED Programs across the board.
 - f. LEAP and Byrd Scholarships were eliminated.
 - g. \$25M was cut from the TRIO Programs.
 - h. \$20M was cut from the GEAR UP Programs.
 - i. \$1.6M was cut from the Jacob Javits Fellowships.
- 2. Clarification that schools that were scheduled to receive the base guarantee only, should not see a reduction in their 2011-12 CB funding allocations; schools that receive a "fair share" amount may see reductions. Our revised CB funding allocations are expected during the week of May 9.
- 3. Continued clarification of the Program Integrity Rules of October 29, 2010, Final Rules, regarding distance programs and state authorizations: Recent clarification from The State Higher Education Executive Officers (SHEEO) and the National Center for Higher Education Management Systems (NCHEMS) will produce a compendium of state laws to assist institutions with compliance efforts related to new state authorization regulations, and produce a directory of agencies and individuals responsible for implementing those laws. Also, the Department of Education announced that it will not limit Title IV student eligibility or establish repayment liabilities for distance activities undertaken before July 1 2014, as long as the school is making good faith efforts to meet state authorization requirements. We are appreciative of NASFAA's role in this initiative and SHEEO's efforts to assist us.
- 4. Continued focus on the implementation of the Gainful Employment rules, and impact on our students, educational programs offered, and colleges and universities.
- 5. Budget Focus in the state of PA and many of our colleges, as we address Pennsylvania's fiscal budget deficit of \$4B. We are fortunate that PHEAA remains a valued partner of PASFAA and all of its members, understanding the importance of its many programs and especially the PA Grant Program, on enrollment, and persistence to degree completion.
- 6. Implementation of the new VA Post 9-11 Veteran's Education Assistance Improvements Act. Some of these regulations take effect August 1 and others on October 1, 2011. They impact the formula used to determine the eligible tuition and fee payment benefit calculation, at private schools, capping the maximum at \$17,500. At some schools, this change in formula may impact the student's YR eligibility, depending upon the school's level of Yellow Ribbon commitment.

Looking forward, we will need to concentrate our efforts on the following:

- 1. The increase of the national debt ceiling and its impact on the continued funding levels for our higher education programs.
- 2. FY12 Budget proposals from the Administration, the House and the Senate: We will work with our Congressional representatives and others, to provide sufficient educational funding to ensure a sustainable financial position, to strengthen education and the workforce.
- 3. Continued Advocacy efforts of PASFAA, EASFAA, NASFAA, our legislators, and our students, in support of programs, understanding that compromises will have to occur. NASFAA communicates to schools via the NASFAA Advocate. NASFAA has recently created the Save Student Aid Face book page and the Take Action Page, both of which can be found under the Special Initiatives tab at the top of the page.
- 4. Student access, affordability, progress to degree completion, and the minimization of overall student debt burden, are critical initiatives and justifications to retain programs which continue to help our students and our schools achieve these objectives.

Spotlight: Mary Miller RetirementColleen Coudriet, Member, Newsletter Committee

Although it's been said that "life begins at retirement," this adage certainly cannot apply to PHEAA's Mary Miller, who retired from a dynamic, 33-year financial aid career on April 15, 2011. Those who have known Mary professionally throughout her vocation undoubtedly have also found her personally to be an ally, enthusiast, friend and fun-lover. It's been a wonderful life thus far and here's how it has played out...

Diving into the financial aid world in 1978, Mary accepted a position as Assistant Director of Financial Aid at the University of Pittsburgh where she handled Pell Grant processing and counseled students/parents. In 1979, Mary became Director of Financial Aid at Mt. Aloysius Junior College. There she coordinated all aid resources available to students, was chief-in-charge of financial aid reports, forms and procedures, and also supervised/trained financial aid staff in addition to student workers.

In 1981, Mary began a lengthy tenure at her alma mater, Indiana University of PA, when she became Associate Director of Financial Aid. Her duties were expanded to include: management of the automated financial aid database system, coordination of the financial aid process for the Learning Center, oversight for academic scholarship programs, supervision of office personnel, consultation with students/parents, representation of the financial aid office on university committees.

Slippery Rock University of PA was next to benefit from Mary's expertise, as she joined the college in 1994 in the role of Director of Financial Aid. Along with many of the duties she performed in previous positions, Mary now was responsible for developing a policies and procedures manual, managing the technological advancement of the financial aid office - including hardware/software upgrades and the design/ maintenance of the financial aid office homepage, as well as providing statistical analysis and reports showing financial aid trends to aid in recruitment and retention.

AES/PHEAA came calling in 1998, as Mary was hired to manage the Education Services Group. In her ESG position, she championed the services and products of the agency through site visits and training, developed/conducted workshops for financial aid administrators, represented the agency at all regional events regarding student financial aid for postsecondary institutions, participated in local, state, regional, and national meetings and conferences, assisted in the development, design and distribution of

agency marketing materials, worked to evaluate/direct the expansion of the agency's products, and created detailed reports addressing the impact of agency programs/projects toward the agency's goals and objectives.

In 2007, PHEAA elevated Mary to the position of Vice President, Pennsylvania School Services. In this capacity, she was charged with providing oversight for the administration/promotion of goals, objectives, programs, products and services to secondary and postsecondary schools, legislative and community groups. Additionally, she managed the PA School Services Access Partners throughout the Commonwealth, served as an advisor to senior management on issues related to secondary and postsecondary schools, participated in meetings with other state agencies and organizations related to outreach and/or financial aid matters, served as the liaison to the executive leadership of PASFAA, conducted presentations/ training at state, regional, and national conferences, created/monitored the annual operating budget for PA School Services, and developed workshops for counselors representing secondary and middle schools, as well as civic and community organizations.

As if all that weren't enough to yield a wonderful life, Mary also participated in countless professional volunteer activities and has been the recipient of numerous awards related to that service. In support of the National Association of Student Financial Aid Administrators (NASFAA), Mary has chaired the Training Committee and worked on the Leadership and Professional Development, Conference and Membership Services committees. She was honored as a member of the Leadership and Professional Development Committee, earning the Committee of the Year Award in 2004. Holding membership in the Eastern Association of Student Financial Aid Administrators (EASFAA), Mary chaired the Electronic Initiatives and Conference committees, and earned accolades in the President's Award and Committee of the Year Award, both in 2004. Here at home, Mary has served PASFAA as president, vice president and treasurer. She has been a member of the Finance and Development, Technology, Federal Relations, Conference and Leadership Development committees. Additionally, Mary has chaired the Conference Committee and the PA Financial Aid Training (PFAT) Program

and been the webmaster of PASFAA.org. She also received the PASFAA Distinguished Service Award in 1996.

asked about her greatest professional accomplishments, Mary indicated that her service in PASFAA produced most of those moments. "I believe I held every (PASFAA) office except for secretary. This provided me with the experience to serve in leadership roles in EASFAA and NASFAA," she noted. "I have so many fond PASFAA memories. The most memorable occurred at the annual PASFAA conference during the year in which I was selected as the recipient of the Distinguished Service Award. I almost didn't attend the dinner to receive this surprise recognition because of an incident on the golf course. Golfers beware: It doesn't matter if you are behind a tree when Vince Racculia is on the course, (as) he can thread a golf ball through anything and manage to hit a body part -- in this instance it was (my) elbow...ouch!"

While Mary holds that particular PASFAA conference in high esteem, her friend and colleague Bill Burke of the University of Scranton mentions this one, "One memory I'll never shake was Mary playing polkas on an accordion at a PASFAA conference." Bill continued, "Gosh, so many great memories with Mary. I met Mary at my first PASFAA conference 30 years ago. She was already active in PASFAA activities. That's how I'll always picture Mary: wholeheartedly involved in all aspects of financial aid -- PASFAA, EASFAA, NASFAA and PHEAA. She wore many hats, all of them perfect fits."

Chris Zuzack of PHEAA, another of Mary's close friends, pointed to this memory, "Mary Miller went all out whenever she chaired the EASFAA conference in Providence, RI in 2004. No detail was too small to attract her attention. She even managed to have one of her staff members dress up in a red lobster costume and walk through the conference attendees! This certainly put a smile on everyone's face and we all had a great time with it." Chris added, "Mary's dedication to financial aid is phenomenal! Never one to shirk away from a commitment, Mary came to a financial aid training program coordination meeting when she was nine months pregnant with her first child. We were all on the ready, in case the baby decided to come early, but Mary went on about her business in getting the meeting's agenda completed. Thank goodness the baby (Marisa) waited until a more opportune time to come forward."

Fellow AES retiree and pal Rachael Lohman shared this, "I met Mary for the first time in 1981 at the PASFAA conference. I knew even meeting her for the first time that there was something special about her. I cannot think of anyone more dedicated to our profession and to helping others be successful. Through the years I especially loved working with Mary as a trainer or presenter. She knows how to keep her audience engaged, to have fun with them, and to teach -- all at the same time."

With so many colleagues expressing their appreciation for Mary's years of service, she is quick to acknowledge the importance of mentors and financial aid associates. "There are so many that have influenced my professional life. Fred Joseph, Bill Srsic, Jeanne Lynott, Frank Dutkovich, and Vince Racculia all served as mentors. Colleagues who have become life-long friends as well as my trusted advisors include Helen Nunn, Jan Napiltonia, George Walter, Rachael Lohman, and Chris Zuzack," Mary noted. "And, I can't forget my husband Ken. Without him, I would not have been able to accomplish so much throughout my career. I am sure his knowledge of financial aid and higher education is something he hadn't planned as part of the 'I do' of our marriage."

When invited to address her lessons learned in financial aid, Mary replied, "Keep the focus on the students. It is so easy to get mired in regulations, policies, procedures, etc., all of which are important, but secondary to meeting the needs of the students who seek financial aid assistance. Also, find a good balance between your personal and professional life."

Mary offered the following advice for those that are new to financial aid, "This can be an overwhelming profession; however, it constantly changes in such a way to keep the position interesting as well as challenging. Become involved in campus committees and PASFAA, EASFAA, and NASFAA committees. I have met so many people and visited so many places throughout the country because of my involvement in these organizations."

"No one aspires to be a financial aid professional when they 'grow up'. We are in this profession for a reason," Mary pointed out. "We are a dedicated group of individuals who care about people, including staff, students, and families. How lucky I have been to get to know so many of you. Thank you for all of your support over the years, well wishes on my retirement, and all that you do to help students and families."

So, it seems one volume of Mary's wonderful life has been put on the shelf. Without question, there will be more to follow. Akin to George Bailey in Frank Capra's classic film It's a Wonderful Life, Mary Miller has touched so many people and truly made a difference. Fortunately, we don't have to imagine what life in the financial aid community would've been like without Mary to appreciate her contributions; we can revisit our memories frequently and strive to carry on in her likeness.

Justin Draeger: The Man behind the Position Christopher Mowl, Member, Newsletter Committee

I remember the first time I saw Justin Draeger speak. It was via a NASFAA web conference in early 2010. Many of you may have had the same reaction I did when I muttered to myself these exact words: "Wow, he's...young." Several months later in May of 2010, NASFAA would tap this young gun as their new President and CEO.

NASFAA, or the National Association of Financial Aid Administrators, is the largest postsecondary education association with institutional membership in Washington, D.C. They provide an incredible amount of support to both students and financial aid offices in terms of training, lobbying, and performing regulatory analysis at the national level. Amidst the flood of change in our industry, NASFAA has been a strong ally as many navigate through new and wonderful lands, like Direct Loans, the Net Price Calculator, and the regulation of the Private Loan industry. Many of us were fortunate to see NASFAA's Justin Draeger on the last day of the 2010 PASFAA Conference in Lancaster. In his speech he spoke to us about "being an advocate to both students and families." It was a great reminder of why many of us do the job we do, to provide an outstanding service to the students and families we represent. I came away from his speech both inspired and with a desire to learn more about Justin Draeger. On a dreary and rainy Tuesday morning, I had the opportunity to speak to Mr. Draeger by telephone. I could immediately tell how the conversation would go, because when I said "Mr. Draeger, this is Christopher Mowl from PASFAA" his immediate reaction was "Please, call me Justin."

He was born in Toledo, Ohio, coming from a hard working, blue collar family. Turns out Justin Draeger got into financial aid the way many of us did, he fell into the job. Married young and in College, he said "I had two choices: I could be a DJ, or I could work in a financial aid office." From there he worked his way up, serving financial aid as a counselor and eventually a director. He moved on to become a regulatory analyst at a state guarantee agency before ultimately taking a position with NASFAA in 2006. He was selected to serve as NASFAA's President and CEO in May of 2010. In his spare time he enjoys yoga, and is an avid racquetball player. Spare time is a tough commodity though, considering his position. NASFAA maintains its headquarters in Washington D.C.

I asked Draeger if he ever felt intimidated because of his youth while holding such a prominent position. He replied "What some people view as a weakness, you should embrace as strength." He continued by saying "Youth can mean vitality, energy, and excitement." With his time in Washington, I wondered who might be the most prominent member of government he enjoyed meeting the most. True to his blue collar roots, he answered "Honestly Chris, a lot of legends live in D.C., but I enjoy my time with the workers. The Congressional staffers, the people with the Department of ED, financial aid workers. That's where the real relationships

Real Life Heroes Sow Magic Seeds

Don't spend your money on the latest Harry Potter flick! For your summer enjoyment, here's a little tale about heroes, financial aid and magic seeds.

Once upon a time, in the Commonwealth of Pennsylvania, there lived a University called Kutztown. The University could do many wonderful things, but it needed a constant supply of young adult minds to do even better things. Many of the young minds the University was interested in dwelt in the surrounding towns and villages and attended the local schools. Some of the minds had only one parent at home, some had different backgrounds and ethnicities than the other minds who lived at the University, some lived in scary neighborhoods, and many had financial limitations; but for whatever reasons, many of these young minds believed that they could never enter kingdoms known as universities.

In the University, there lived a Financial Aid Office where the financial aid heroes of our tale were busy all day long sowing and reaping data. While they worked, they dreamed. They dreamed of planting seeds in young minds through early intervention. "If you plant the seed early enough, you might make a difference along the way," was their credo.

Since they lived in a world of research, the financial aid folks had lots of evidence* that breaking the spell of discouragement would be the first step to unlocking the keys of the kingdom of college for the young minds.

In the book of knowledge (known as research), it showed that college enrollment decisions, access to college, and success in college are all tied to aspirations, support, and academic preparation. Statistically, students of color, students from low-income families, and students whose parents don't have college experience are less likely to attend, persist, and to graduate from college because they lack these key foundations. The grim reality is that students like these, without the appropriate math and reading skills by eighth grade, are unlikely candidates for college.

The difference between a disadvantaged student succeeding in college or not can be as simple as the intervention of one person - a mentor or a role model, the book of knowledge says. Similarly, the difference between parents and their students believing that college is financially impossible and believing that college is an option is often simply learning of the existence of financial aid.

Preliminary research also suggests that participation in an early intervention program can help ameliorate disadvantaged students' ability to attend college.

Knowing all this helped our heroes determine that fifth grade was a good age to start an early awareness program. At that age, students are not too young to absorb the concept of college, and at the same time, negative messages are not so ingrained.

One of the former staff members in the Financial Aid Office at KU suggested that they "adopt" a local school where young minds studied, to grow research into reality. The suggestion took root, and Lauer's Park Elementary School in nearby Reading was duly selected for adoption. The F.A. staffers reasoning was thus: K.U. already had a connection with Lauer's Park - they formerly sent student teachers there. Under the principal's dedication, Lauer's Park Elementary School was an oasis in a neighborhood filled with crime and violence. Many of the children at the school had never ventured outside of their own neighborhood, and therefore had limited knowledge of opportunities beyond that neighborhood. If you plant the seed early enough...

Luckily, F.A. staffer Joan Holleran was a teacher in a previous kingdom. Already familiar with planting seeds, Joan was chosen to work a little magic. She was to create a spellbinding plan to promote the possibility of higher education for families who, without intervention, would most likely not consider going to college as an option.

Joan dug through mountains of literature on early awareness programs for children and ended up creating both a student and a parent program from a compilation of materials that continues to evolve today..."Nothing was exactly what I wanted to do, but putting bits and pieces together gave us a good start," Joan said. "I focused on career exploration, education, and finances." Joan's eventual program design was for an academic year-long series of hands-on workshops to be presented to the fifth-graders by Financial Aid Office staff members. Hour-long activities

and meetings were also to be scheduled from September to May for parents. The "College Can Be a Reality" program would include two field trips to the KU campus, and a visit to a cultural event on campus. Handouts, workbooks, audiovisuals, and other materials were carefully chosen or prepared for fifth grade minds. F.A. team members also made available written materials in Spanish for parents with language barriers. Certificates of completion were readied to be given to students and parents at the end of the program.

"The major goal of the program is for the students to go on to some form of higher education...to the form of higher education that will best prepare them for the world of work." Joan says.

"To get there, we have to plant, nurture, and grow the seeds of self-esteem, communication skills, high academic standards, strong work ethics, motivation to stay in school, and positive attitudes about their ability to enter college."

With the blessing of the former director of Financial Aid, Anita Faust, and KU's upper level administration; along with the support of Lauer's Park Elementary School principal Gordon Hoodak and his fifth grade teachers and guidance counselor, the next task was to choose participants. Lauer's Park's guidance counselor and teachers selected about 30 students who they believed had the potential to succeed in college to participate in the program.

The program year starts in early September with a mandatory joint student/parent session to introduce the program and confirm the parents' commitment to participate. It includes a popular paper airplane exercise that serves as an analogy to illustrate how having time, information, and experience can lead to successfully preparing for college.

The student component begins in September with a discussion of "Who Am I?" October's journey is "An Adventure in Learning." In November, students learn "How to Get There From Here," and in December, they come to the Kutztown University campus with their parents for a full day of hands-on experiences. January's lesson is "Matching Your Career to You," and in February, the students figure out "How Can College Help Me?" In March, students learn that "The Right College is Out There and It's Affordable Too!" And in early April, they discover that "If It's a Career, It's Here." The program concludes in late April with the students' and parents' final visit to KU for a grand finale and awards presentation.

The parents' start their sessions in October learning that "Education is the Pathway to Opportunity." In November, they examine "The Cost of College and How to Pay for It." In December, parents join their students for a day long visit to the KU campus. The January session looks at how "College Admission is not a Lottery and How Parent Involvement Influences Enrollment." February follows with "Charting a Challenging High School Experience" and the March session is a review of the whole year with a spirited competition called "20 Questions."

And the rest, as they say, is history. "Thanks to the commitment of the Financial Aid Office staff and the continued support from the KU administration and the elementary school principal," Joan adds. The magical community outreach program just wrapped up its sixth successful year with approximately 175 students having gone through the program since its inception. "We have several parents who have had a couple of their children in the program over the years. That tells us it's worth it," Joan explains. "All parents want their kids to have it better than they did. We show the parents and the students...that college can be a reality for any child who is prepared."

Joan's fellow magician gardeners are Financial Aid staffers Claudia DeLong, Maggie Monet, and Lisa Schroeder, who as a team present the program to students and parents, and also assist in evaluating it annually and revamping it when necessary. Financial Aid Director Bernard McCree is a staunch supporter, and funding for the program has been incorporated into KU's annual budget.

"We didn't have the time to do this, and we have even less now, but we've made (the program) a part of our office's workload," Joan explains. "Those of us doing the program hands-on have seen the change it makes in the student and parents over the course of a year's time. We're (all) committed to it."

"I think we better serve our underrepresented populations on campus having been a part of this program," Joan concludes. "When you work with students and their parents as intimately as we have in this program, you have an understanding of where they came from and what challenges they brought to school with them."

In the real, non-fairy tale world, the Financial Aid Office would maintain a connection to the students as they move on to higher education, Joan says, but adds that this goal has yet to be reached, due to limited human and financial resources.

The happy ending is that the seeds so carefully planted are flourishing as the young minds are moving through middle school to high school. And since the magical gardeners at KU have developed such expertise with seedlings, they hope that other gardeners in other kingdoms will want to grow those seeds as well.
