### What is an SCO?



### **School Certifying Official**

- Duties and Responsibilities
- Where the rubber meets the road
- > Face of the VA
- Get no credit when things go well, and all the blame when things do not

## Background



- I was the SCO for the University of Pittsburgh from 2009-2015.
- ➤ Each term I certified between 420-450 Students receiving Education Benefits. Submitted certifications for each student to include 100-125 adjustments each term.
- Cost was approximately between \$7,000,000- \$7,500,000 each year.
- Current member of the Pennsylvania Department of Education, State Approving Agency. Responsible for approving schools to use the GI Bill ® and approve programs at each school within the Commonwealth of Pennsylvania.

#### What is needed for each Certification?



- Student Class Schedule- Determine Credits taken
- Student Ledger showing tuition and fees-Determine Actual Net Cost
- List of Scholarships, Grants, Student Aid that each student receives
- List of students receiving Tuition Assistance
- Are classes Resident, Hybrid, or Distance Education
- Study Abroad
- Remedial & Deficiency Courses
- Where are classes being taken

#### What is needed for each Certification?



- Is the school Private or Public?
- Public- No cap, the VA will pay the Instate Tuition rate
- Private- Currently \$24,476.79
- Yellow Ribbon Program- Student must be at the 100% benefit level to be eligible for the Yellow Ribbon Program
- School must apply and be approved to be a Yellow Ribbon School
- Once Cap is reached, the difference will be split between the school and the VA.

## Using Resources



#### What Resources are Available to SCO's

- SCO Handbook- First place SCO's should turn to when they have a question
- VA Once- System to process certifications
- State Approving Agencies, Education Liaison Representative, Workshops, Webinars, Conferences, Newsletters
- Organizations such as PASFAA, NAVPA, AVECO
- ➤ Title 38 CFR USC, M22-4, State and Federal Regulations, Policy Letters, Policy Advisories

#### **Best Practices**

- ➤ Submit a question-Ask a Question Right Now Web (RNW)
- >SCO Hotline 1-855-225-1159
- ➤eBenefits- Everyone using benefits should have a premium account. See payment history, how much entitlement veterans have remaining, search for jobs, and delimitating dates.
- ➤ Partner with a similar school- NCD, IHL, See how they handle issues. You're not the only one who has had an issue.

### **Best Practices**



- Work Study Program- Paid by VA, not the school.
- ➤ Paid minimum wage, tax free. Work in office doing only VA/Certification support.
- Great part time job for veterans/dependents.
- ➤ Must be receiving a chapter benefit at 75% or 3/4 —time or greater.
- Works 30 days prior to start date and up to last day of certification.
- > Signs a contract with VA. Work study manager sends them. SCO sets time schedule, signs time sheet.

## **Develop Systems**



- Reports for when a student changes schedule, changes schools or receives a Non-Refundable Scholarship
- You can not rely on Student's informing you of when they change their schedule. You must develop some sort of tracking system
- Debt Management- School Debt & Student Debt
- School Debt- Charged to school, example is if a student registers for classes, then withdraws prior to term starting. School is not entitled to funds since student didn't attend. School would be liable for debt
- Student Debt- When a student takes action to create a debt such as withdrawing from classes. The debt will be charged to the student

## Challenges that SCO's Face



- Regulations are consistently changing
- Harry W. Colmery Act- 31 Provisions to the GI Bill ®
- Some changes went into effect immediately, some don't go into effect until 2022
- Most changes are beneficial to the veteran, how ever will make the process more difficult for SCO's
- SCO's must report by zip codes/branch/extension sites where the student is taking the classes

## Challenges that SCO's Face



- Most SCO's wear many hats, they are the Financial Aid Director, Registrar, Counselor, and the SCO duties are the last job they do
- ➤ In my experience these are the SCO's that have difficulties because this is not their primary job
- School's that only have one SCO, SCO hit's the lottery and leaves suddenly and no one to fill in that knows what they are doing or even where to begin

### Advice



- If you have SCO's that work for you allow them to attend any and all training events so they can stay current
- Have a back up SCO that is familiar with the certification process
- Develop a job book of how to do their job
- Seek out another SCO in your area that has a similar school
- Use your resources, Education Liaison Representative, State Approving Agency, SCO Hotline, Ask a question
