

Huge Student Loan Servicing Shakeup: This Major Loan Servicer Is Ending Its Contract


A major student loan servicing shakeup is in the works as one of the Department of Education's primary student loan servicers seeks to exit the business.

The Pennsylvania Higher Education Assistance Authority (PHEAA), which operates
 FedLoan Servicing, has informed its employees that it plans to end its federal student loan servicing activities when its contract with the Department ends this December. The contract was originally supposed to end in 2019, but was extended several times, and PHEAA will not accept another extension or seek renewal. The news was first reported by PennLive and Politico.

PHEAA and FedLoan Servicing have been accused of widespread mismanagement of federal student loans. As the primary servicer designated by the Department of Education to manage key federal student loan programs like Public Service Loan Forgiveness (PSLF) and TEACH Grants, the servicer has been scrutinized for what critics say are deep, systematic problems.

PA State Grant Program

- Isaiah Skeete, a senior at Waynesburg University, awarded the \$12 billionth PA State Grant dollar
- Since program was created, awards to nearly 3 million Pennsylvania students
- 2021-22:
 - Grant awards to ~110,000 students
 - Max award of \$5,000, the highest award amount in the program's history



PA State Grant Program

• PHEAA has contributed more than \$1 billion from its business earnings to supplement the PA State Grant and other student aid programs.

Every dollar appropriated to those programs goes directly to benefit the students who need it most!

2022-23 Commonwealth Budget

- PHEAA Board of Directors approved budget request of \$350 million for the PA State Grant Program, a 12.8% increase
- Maintains the max award at historic high of \$5,000
- Also approved request for 2.5% increase in other student aid programs

- Act 101 Program served more than 20,000 students over the last decade
- In 2020-21, assisted 3,668 students at 34 participating institutions of higher education throughout the Commonwealth



PA Forward Student Loans


- Low-cost affordable student loan products, originated and serviced through PHEAA, available to help PA students and families




PA Forward & the CARES Act

- Benefited 5,739 borrowers with 6,000 loans
- March 13, 2020 Sept 30, 2020:
 - Interest rate on PA Forward
 Loans was reduced to 0% while
 suspending required payments
 - Late fees waved
- March 13, 2020 Jan 31, 2022:
 - Wage garnishments not pursued
