#### EXECUTIVE COUNCIL MEETING

PASFAA Executive Council met in Harrisburg at Towne House on May 13.

Reporting for the Membership and Elections Committee, Chairman Sal Ciolino notified Council that seven new memberships had been received. He indicated that he would be willing to provide information materials to any interested persons referred by current members.

In the President's Report, President Ferrara indicated that he had represented the Association in a letter to Dr. Haskell Rhett of New Jersey in making inquiries regarding the New Jersey state grant program. Generally, the letter commented that Pennsylvania aid officers find the program difficult to administer.

Mr. Ferrara announced that the 1982 EASFAA meeting will be held in May in San Juan, Puerto Rico.

President Ferrara presented letters of resignation from Jennie Taylor as Corresponding Secretary and from Janet Gebhardt as Treasurer. Both letters were accepted by Council and upon presidential appointment, as specified in the PASFAA constitution, Helen Nunn of Allegheny College will replace Ms. Taylor and Namey Meyer of Bucks County Community College will replace Ms. Gebhardt until a regular election can be held at the October meeting. At that time, a special election will be held to fill the last year of these two-year positions.

In old business, John Brugel reported on the likelihood of continuing SSFATP training beyond this year. Since federal funding for this program has run out, Dr. Brugel, together with Barbara Williams of PHEAA's Special Services Division, is working to coordinate efforts between PHEAA and PASFAA to continue this training. This is supported by Article II, Section 6 of the PASFAA constitution which provides for PASFAA's involvement in and responsibility for training and information dissemination to aid professionals.

In new business, President Ferrara noted that he is doing research on the subject of cancellation of GSL and NDSL indebtedness in return for military service. This program is intended to offer incentives for young Americans to join various branches of the armed services. At a later date, Mr. Ferrara hopes to be able to clarify the effective dates of the program as well as implementation procedures.

John Brugel announced that the Conference, 1982, will be held at the Harrisburg Marriot. Bill Boyd of Penn State is the Conference Chairman.

The next Executive Council meeting is scheduled for 11:30 A. M. October 4 at the Pocono Hershey.

# REPORT OF THE GOVERNMENT RELATIONS COMMITTEE

The agenda and registration materials for the NASFAA conference have recently been mailed to all member institutions. This National Conference on Financial Aid will be held in Washington, DC, from July 29 to August 1. An important part of the conference program will be meetings between members of Congress and financial aid officers; PASFAA is coordinating this effort for Pennsylvania aid officers. # GARY SMITH ADDRESSES COUNCIL

Gary Smith, PHEAA Deputy Director for Grants, gave Executive Council an update on the 1981-82 PHEAA grant program at their May 13 meeting. Mr. Smith indicated that PHEAA's listing of assured/conditional awards is relative to the state appropriations for the program rather than to uncertainties in the Basic/Pell Grant Program. A bill has been voted on in the Senate Appropriations Committee which asks for only \$1 million additional state grant funding (beyond the amount that is forward-funded) instead of the \$2 million requested by the Governor.

Mr. Smith also discussed the percentage reduction in the Pennsylvania State Grant for 1981-82. He stated that there are two percentage factors relevant to the need analysis which must be considered to understand the reduction. First, there was an eight per cent across-the-board reduction to all calculated awards. This enabled the Agency to reduce its spending from the \$88 million required to meet need for all applicants to the \$82 million threshold recommended by the Governor. Further, since the Agency is only guaranteed \$80 million under forward funding, the final term awards for the academic year were reduced again for a total savings of \$2 million. This computes to be a 4.4 per cent reduction to the second term award at a semester institution or a 6.6 per cent reduction for the third term at a quarter institution. Although the percentages are different, the total dollar value reduction is equivalent.

# NEW REVISED NDSL PROMISSORY NOTE ISSUED

The Department of Education has issued a new revised NDSL Promissory Note. Copies of the note are being prepared and will be mailed to all participating institutions by ED.

The original note, reflecting changes in the NDSL program as a result of the Education Amendments of 1980, was published originally in the January 19, 1981 Federal Register. Unfortunately, the provisions listed did not include the six-month grace period after deferments. The Promissory Note has now been rewritten to include this grace period and clarify language in areas where legal or interpretive issues have arisen.

The Department of Education strongly recommends that institutions begin using the new note as close to July 1, 1981 as possible. If an institution has already printed the original revised note, and reprinting it would cause a serious financial problem, an addendum may be attached to the January 19 note. The addendum printed in the November-December, 1980 issue of The Bulletin from ED is NOT sufficient, and the addendum printed in the March-April, 1981 issue of The Bulletin is NOT correct.

If either or both of the November-December, March-April addendums have already been attached, they must be removed and any reference to them in the note must be eliminated.

After July 1, 1981 institutions are expected to include the student's social security number on any loans assigned to ED, as this is often the only way to trace defaulters. Institutions may want to consider including this information on the required loan forms that would be transmitted to ED when loans are assigned.

Among the provisions being debated in Congress for the FY 1982 budget is an increase in the MDSL interest rate. Institutions may want to leave this space blank when having new Promissory Notes printed so that the appropriate rate can be entered on the date of the signing of the note.
