Council Meeting Minutes

April 5, 1993 and June 7, 1993

- The April 5, 1993 PASFAA Council Meeting convered in Harrisburg, PA in the PHEAA Board room.
- The Conference Committee is planning a special semi-formal event at the Carnegie Museum to celebrate the 25th anniversary. PASFAA has authorized a special expenditure from the general fund to assist in the extra expenses for the celebration.
- The refund policy for vendor/sponsors was finalized.
- Discussion on the daily rate for conference attendees continues. The Conference committee was charged to review the proposal again for final consideration at the June meeting.
- The Membership directory is being printed. PNC has agreed to provide assistance with the printing of the directory.
- Linda Brittain has written to Senator Wofford and other PA legislators on behalf of the PASFAA membership regarding Direct Lending.
- · The results of the Direct Lending survey were distributed and discussed.
- The Professional Standards and Training Committee submitted nominations for consideration for P&PDC. Council voted on the slate of candidates presented for consideration.
- Thirty-nine sites across the state have been chosen for the 1993 High School Guidance Counselor Workshops. These workshops will take place in November and December, 1993.
- Don Shade reported that the Public Two Year Sector will be meeting April 22 and 23 in Harrisburg.
- The June 7, 1993 PASFAA Council Meeting convened in Harrisburg, PA in the PHEAA Board room.
- Due to consolidation of two sites there will be Thirty-eight sites across the State hosting the 1993 High School Guidance Counselor Workshops. PHEAA Regional Directors are currently organizing the sites and work is already progressing on the syllabus for the workshop. Letters to request volunteers to serve as presenters or site registrars will be going out early summer.
- Ron Shunk advised Council that a survey will be sent out to the membership to assess the training needs to assist PAATP in planning their training programs for next year.
- A Conference fee of \$150 was approved by Council. A daily rate of \$80 was also approved.
- The Conference committee is planning a special celebration at the Carnegie Museum and bus transportation from the hotel to the museum is being provided. The Conference attendees are encouraged to use this bus serivce to and from the celebration.
- Ron Laszewski reported that on June 1, letters to solicite nominations for President-Elect and Council members went out to the membership and are due back on June 30.
- Nominations were received and a candidate was selected for the Distinguished Service Award.
- Linda Brittain presented a brief update on the recent programs on Direct Lending given by PNC and Larry Oxendine. Additional updates regarding the status of the Direct Lending bills were presented.
- Georgia Prell reported on the recent SSHE meeting at West Chester and Cheyney.
- Don Shade reported on the April meeting of the Public Two Year Sector. They viewed the NASFAA Technical Update video and received updates from PHEAA representatives.
- Due to a recent job change of Margaret Hynosky, the Private Two Year Sector position is open. Betty Davis could have appointed a replacement for this position on Council but it was decided not to since June was the last meeting and all new Council positions will be up for consideration at the Conference.
- Ron Shunk reported that Clarke Paine has reviewed numerous sites for the 1996 Conference. Split Rock Lodge was presented for
 consideration for the 1996 Conference. Council moved to accept this recommendation subject to a second visit by a Council member
 and some minor negotiations on the contract.
- Betty Davis reminded all Council members and Committee Chairman that Annual reports are due to be sent to her by September 1,1993
 for inclusion in the Conference materials.



Can You Say No 'Nicely'?

TEST YOURSELF AND SEE—

"It seems to me that unless you give in completely when a customer complains, the customer will be unhappy. Yet company policies don't always make 'yes' possible. How can we make these customers happy?"



As a complaint handler you're expected to have concern for the customer and understanding of his or her problems. That means some problems will be resolved in the customer's favor and other times in the company's favor. No matter what the outcome, you should always work to salvage the relationship with the customer. The following quiz can help determine whether you are handling such complaints delicately and can say "no" nicely.

9.	When possible, do you explain to customers how future problems can be avoided?

Your score: Nine or 10 yes answers suggest you're able to say "no" to customers successfully because you offer understanding and present them alternate solutions. A lower score indicates you need to show more empathy to unhappy customers. Hear them out, then focus on a solution that works for both the customer and your company.

PENNSYLVANIA TUITION ACCOUNT PROGRAM

On June 24th, college presidents were invited to attend the "Introduction to the Pennsylvania Tuition Account Program" hosted by Catherine Baker Knoll, Treasurer for the Commonwealth of Pennsylvania. Of the approximate 50 individuals in attendance, PHEAA representatives and financial aid officers were present in the audience to listen as this new program's parameters were outlined.

The basic premise of PTAP is to allow families to purchase tomorrow's college credits at today's costs. Many questions regarding taxation benefits, asset calculations, educational resource determinations and impact upon federal methodology were raised. Unfortunately, answers were not as definitive as we had hoped. Eileen M. Ferry, Director of the newly created PTAP Bureau, encouraged all concerns and questions be directed to her attention at (717) 772-5000.

Official announcement of this program is scheduled September 9, 1994. Knoll assured all present that prior to implementation of this program, a series of regional workshops and presentations would be held in order to better acquaint aid offices with the specifics of this new program. Knoll stated her hopes of PTAP becoming the model program for other states to emulate.

At this time, PTAP is requesting all institutions supply the following information to their attention:

- 1) Designated institutional liaison for PTAP information
- 2) 93-94 tuition rates
