

PASFAA 2002 Elections



The candidates who have agreed to have their names placed on the ballot are listed in this newsletter. In accordance with PASFAA by-laws, the two persons receiving the highest number of nominations for each office have their names placed in contention. In addition to the names listed in the newsletter, the Sector Representative for the Business Trade and Technical Sector remains as an open position.

Ballots will be place in the conference packets for individuals eligible to vote. Active members may vote for the Office of President-Elect, Vice President, Secretary, Treasurer, and Representative At-Large.

At the opening session of the annual business meeting on Sunday, October 20, 2002, the candidates will be introduced to the membership and nominations will be received from the floor for any of these positions. Voting will occur at the conference with the ballot box being located at the PASFAA table in the vendor area. Balloting will end at 12 noon on Tuesday, located at the passage. Absentee Ballots



In keeping with the procedures adopted by PASFAA, absentee balloting will be available to persons unable to attend the conference but who have renewed their PASFAA membership for the upcoming 2002-2003 year. On the 2002 conference registration form there is a provision for individuals who cannot attend the conference to renew their membership and to request an absentee ballot.

Absentee ballots must be requested on or before Friday, September 20, 2002. Ballots will be mailed upon receipt of a request. The completed ballot must be returned to the Past President at least one week prior to the

start of the conference, using the double envelope method. The Past President will bring any such ballots to the conference where they will be opened and counted by the Membership and Elections Committee prior to the counting of ballots cast at the conference. Write-in votes are only acceptable for individuals nominated from the floor at the conference. Therefore, members casting absentee ballots can only vote for individuals printed on the ballot. individuals printed on the ballot.




Playing Politics with Administrative Relief

The week of July 15, 2002, was an especially bad one for Financial Aid Administrators seeking relief from administrative burdens. It isn't that Members of Congress, the Bush Administration, and the higher education community aren't concerned about providing such relief; it's just that some of them allowed politics to get in the way of achieving this goal.

Extending the Low Default Rate Provisions

As you know, two provisions that provide administrative relief for schools that maintain low default rates expire on September 30, 2002. These provisions allow schools that have default rates below 10% for three consecutive years to waive the 30-day loan disbursement delay for first-time freshmen borrowers and to disburse loans in single installments if the loan period is equal to a single academic period (semester, trimester, quarter, etc.).

To extend these provisions for an additional year adds approximately \$10 million to the federal



was not an easy task. After, literally, months of trying, the House Education and the Workforce Committee and the U.S. Department of Education agreed that the money could come from a general administrative fund that is authorized under Section 458 of the Higher Education Act. Funds in this account are used to pay for the operations of the Federal Direct Loan Program (FDLP), to fund some guaranty agency operations, and for general support of administering the student aid programs. The Department of Education assured Members of Congress and the higher education community that taking \$10 million from the 458 account would not effect student aid delivery or the operations of the FDLP.



Despite these assurances, most of the higher education associations based in Washington, DC opposed using the 458 account as the source of funds to pay for extending the low default rate provisions. These associations urged Democratic Members of Congress to oppose this provision. Because Democratic votes were needed to approve these extensions, the whole idea was shelved and its fate, at press time, is uncertain.

Additional Administrative Relief - the FED UP Act

The low default rate extensions were intended to be added to the FED UP Higher Education Technical Amendments Act of 2002 (H. R. 4866). This bill included numerous revisions to the statute, most of which were suggested by schools and other program participants as part of the FED UP initiative launched last year by Rep. Buck McKeon (R, CA) and Rep. Patsy Mink (D, HI). This bi-partisan effort collected in excess of 3,000 suggestions for improving the federal higher education regulations. Some of these items were addressed in this year's negotiated rulemaking sessions and the resulting Notices of Proposed Rulemaking that were published this summer.



Among the items included in the FED UP Act, were some relief on the Return of Title IV Aid policy, an easing of the process through which borrowers may obtain forbearances, and clarifications regarding the eligibility of certain schools and students for Title IV aid. Individually, none of these items are earth-shaking; collectively they were an important step towards general administrative relief in the student aid programs. And, they were a sign that Congress could deliver on the promises made when the FED UP process was launched.

Unfortunately, politics – DC-style – caused the defeat of the FED UP Act. Democratic Members of Congress, led by Rep. George Miller (D, CA), ranking Democrat on the Education and the Workforce Committee, wanted to offer a number of amendments to the bill that were either costly or involved major policy changes that did not have bi-partisan support for inclusion in the FED UP Act. Because the FED UP Act was being considered in the House of Representatives under special rules that required a two-thirds majority for passage, the bill was not approved, even though it received 246 votes in its favor and 177 against.

This is another case where the Washington based higher education associations let us down. They did not believe the bill was important enough to risk bucking Rep. Miller and his colleagues and, thus, the associations did not exert any particular effort to urge members to drop their political stance and support the bill.

Lessons Learned

While I am hopeful that, by the time you read this article, the FED UP Act and the low default rate extenders will have become law, I am far from certain that they will be finalized. But I am sure that we have learned some valuable lessons in the process. First, we have learned, again, how important it is for the financial aid community to stay informed of what is happening in Washington, DC regarding the student aid programs. Second, we have learned that we cannot always rely on our Washington based higher education associations to represent our interests.


So, whereas in the past I have often urged PASFAA members to contact their Members of Congress and their Senators, I am now going to add their Washington-based higher education associations to that list. The major associations in Washington that represent postsecondary institutions and lobby on student aid issues are the American Council on Education (ACE), the American Association of State Colleges and Universities (AASCU), the National Association of Independent Colleges and Universities (NAICU), the National Association of Community Colleges (AACC), the Career College Association (CCA), and, of course, the National Association of

Postscript on School Vouchers and Federal Subsidies

In the Spring 2002 issue of the PASFAA Newsletter, I overviewed the case of Zelman v. Simmons-Harris (United States Supreme Court, 00-1751), in which the United States Supreme Court took up the issue of "school vouchers" from a case emanating from the City of Cleveland under the Ohio Pilot Project Scholarship Program. On June 27, 2002, the Court handed down its ruling, upholding the constitutionality of the program even though the vouchers, from a public school district, could potentially be used at private schools with religious affiliations.

This, of course, is not the end of the debate, but just the beginning. With its constitutionality upheld, it will be interesting to see how such programs are developed elsewhere. And as I noted before, it will be very interesting to see if regulations are enacted to restrict how such vouchers are to be used by parents, and by schools, similar to what we have to deal with in terms of how Federal student aid funds are to be handled – i.e., those dreaded "cash management regulations."





The How and What of E-Signatures

Who would have thought that some day students and parents would be able to use an electronic signature to sign their promissory notes? In light of the Department's Government Paperwork Elimination Act (GEPA) and the Electronic Signatures in Global and National Commerce Act (E-SIGN), that day is now a reality. The E-SIGN Act made it possible to recognize an electronic sound, symbol or process attached to or logically associated with a contract or other record and, executed, with the intent to sign the record, as a legally binding signature. In other words, you don't need a "wet signature" any more in order to "sign" a document.







So, what does all of this cutting edge technology mean for you? Well, hopefully, it will help to fulfill the original mission of the Department to reduce costs associated with processing paper-based information. A brief overview of the E-SIGN process shows that depending on the lender and/or their servicer, there are different ways of utilizing E-SIGN.

Using the Office of Student Financial Assistance (SFA) way, a student obtains a USDE Personal Identification Number (PIN) and uses that to "sign" their MPN. Once they have input their PIN, the Student Authentication Network (STAN) verifies the student's information against the SFA database. After a series of steps and after the student reviews their rights and responsibilities, they obtain a transaction code. It is this code that must be input in order to

successfully "sign" their MPN.

Not all lenders/servicers utilize the SFA way of doing E-SIGN. If a student has not obtained a USDE PIN or has forgotten it, some lenders/servicers use their own version of E-SIGN. You need to ask your lender whether they or their servicer are using the SFA process, or, if not, are they at least verifying information using a third party database in order to meet the legal standards of the E-SIGN Act. If they are not verifying information against a third party database, that process may not provide sufficient fraud protection.






Finance & Development Committee





The spotlight is on The Public & Professional Information Committee

The Public and Professional Information Committee (PPIC) might be the only PASFAA committee to lay claim to having a split personality - the Secretary and the Newsletter. The committee performs two separate functions, carried out by two separate arms.

The first arm of the Public and Professional Information Committee is a one-person show, run by the **Secretary** of PASFAA's Executive Council. The Secretary's most important function is taking the minutes of Executive Council meetings and of the annual Conference business meetings. Effective with the Winter 2002 issue, minutes are now accessible to members via PASFAA's website or by contacting the current Secretary, Suzanne Sparrow. Sparrow views her interaction with the newsletter in this vein, "Joan Holleran, Newsletter Editor, is fabulous!" says Suzanne. "The Newsletter Editor really runs the committee. I have absolutely no involvement. I would have if they didn't have someone as qualified as Joan.

One can easily discern that the functions, while remaining separate, are mutually respectful and admiring. It may be a split personality, but it's a happy one.

The Newsletter is the second arm of the PPIC. In 1996, Joan Holleran assumed the Editor position after a stint as a writer on the Editorial Board. Holleran is the personification of a tour de force, but she is adamant about teamwork. When discussing the joint efforts of the Editorial Board, she speaks in downright affectionate tones. It is clear that she depends on them not only for their writing contributions, but also for their creativity and judgment. The Editorial Board came into being under the tenure of the prior editor, Joyce Ballaban. Its purpose was to provide a regular pool of writers, and to act as an impartial body to judge the appropriateness and relevance of material submitted for inclusion. If it's news, if it's instructional, it's always a go." The Editorial Board has, however, blown the whistle on a few occasions and declined to publish some submissions.

Patty Hladio sums up the collective views of the Editorial Board in this way, "I have thoroughly enjoyed my experiences as part of the newsletter staff. Each time I've submitted an article, whether it was about a specific financial aid topic or a self-help topic, I've benefited personally from the information I've put on paper. In addition to being a great way to contribute to PASFAA, it's also been a lot of fun working with the other members of the Editorial Board!" The 2001-02 Editorial Board includes Joan Holleran (Editor), Brian Blackburn, Nancy Chalker, Alisa DeStefano, Dana French, Ragan Griffin, Patty Hladio, Jen Liedtka, Elizabeth McCloud, Kathy Myers, Judy Rile, Danell Schoemaker, David Smedley, Sally Treadwell and Sherry Youtz.

The newsletter is published quarterly but not evenly spaced, due to the coverage of specific activities of the association. Given the volume of information included, it has been running 28 pages, but always in multiples of four as the paper version is printed on both sides of a page and folded in half. The front cover is dedicated to a graphic pertaining to the "big story" along with the PASFAA logo and a border. Regular features include the President's Letter, Washington Update, PELA News, From the Editor's Desk, the Bulletin Board, and

Activity Almanac. The editor sends out reminders to every PASFAA officer, sector representative, and committee chair, who post regular updates of their activities. Perhaps most importantly, the newsletter reports on the events of the collective organization – elections, the annual conference, college fairs, spring training, etc. Speaking of the profession at large, our editor and the editors of other state associations exchange newsletters on a regular basis. The number of other states, however, that still publish a paper newsletter




Website Assists Spanish-Speaking Audience in Planning for Higher Education

In an effort to make sure that all students have the information they need to pursue a higher education, PHEAA has launched EducaciónSuperior, a website designed for Spanish-speaking visitors who are planning for higher education. EducaciónSuperior.org also provides planning information for non-traditional students and parents of students, as well as in-depth information on financial aid programs.

"At PHEAA we have dedicated ourselves to making higher education affordable and available to everyone," said PHEAA President and C.E.O. Michael H. Hershock. "This means that the information must be understandable for all of our audiences. Within the next 50 years 50 percent of the population of the United States will speak Spanish as their first language. It is important that we provide them with a tool for planning for higher education.'

EducaciónSuperior.org is divided into four main sections, the first of which focuses $\overline{\zeta}$ on introducing the importance of higher education to the reader and providing the financial aid information needed to assure the student's success. The second section delves into the many financial aid programs available to help students afford tuition and attain their education goals. The site also hosts a section especially designed for the parents of students headed for higher education. Students should be introduced to the importance of postsecondary schooling at an early age; therefore information is provided to assist the parents of children in

elementary schools as well as secondary schools.





The final section of the site assists adults who would like to continue their education at a postsecondary school. "Ask PELA"

Question:

Are there any rules or procedures for schools to follow when a student's aid package includes a private alternative loan and the student has withdrawn?

Answer:

Since these loans are private loans and fall under the regulations for consumer loans and not Title IV, PELA cannot establish any specific criteria for schools to adhere to for the return of these funds. If the school must return private funds to the student, they should follow their own set guidelines, established at the school, whether they send the funds to the lender or the student. We do recommend that if a portion of the student's refund does involve a private loan, and the funds are returned to the student, the school suggest that the student apply the refund as a payment on their loan.

Let's Get Motivated!

I found

Okay, so you've survived another summer, your students are in class, and you're already thinking about your timeline for 2003-2004 awarding. But, before you move on to a new year, NOW is a great time to think about your most valuable resources – your human resources.



We all recognize that it's the people in the financial aid office that can mean the difference between a good office and a great office, both in program administration and in service to students. However, because of the myriad of outside needs and influences, it is sometimes easy to forget that those we work with need attention and acknowledgement too. Laurie Kirk, President of Growth Strategies for Peak Performance, provides several suggestions to help motivate people to peak performance. In her article "Seven Insights to Motivate Employees," she provides the following insights:

You get what you reward. Clearly define the goals you want each employee to meet, then use reward and recognition to move toward those goals.

What is motivating to individuals varies from person to person. To be on target, ask employees what they

The most motivating rewards take little or no money. Try a sincere thank you, providing information, involvement in decision-making – especially as it affects your employees.

Everyone wants to be appreciated. People want to know that what they are doing is important and meaningful.

Positive consequences will most quickly lead to desired behavior and enhanced performance.

Management is what you do with employees, not to them. Tell employees what you want to do and why. By involving them, you'll more easily gain their commitment and support.

It's not what you believe or say, it's what you do. Practice recognizing people and their achievements on a daily basis.



In her article entitled "Employee Recognition," Dr. Kirk also offers

some simple suggestions for ways to recognize employees:

Remember to follow-up public announcements with a private, personalized letter, making sure you do it in a timely and consistent manner for it to be most meaningful.

Provide opportunities for impromptu celebrations such as surprise lunches, parties or off-campus breaks away from the daily office routine.

Commend employees both publicly and privately for a job well done.

So whether you use any of Dr. Kirk's suggestions above or whether you find other ways to motivate and encourage those who work in your office, NOW is a great time to give some attention to this often overlooked area of our aid offices.


