The Importance of Campus Partners

- Institutional priorities
- Engage directly with students and families
- Can introduce new students to campus community that might not have otherwise applied
- Opportunity to excite students

Fostering Relationships with Campus Partners

- Communication!
 - Transparency (as permitted) and timely updates otherwise
- Quick responses to their constituents
- Engage creatively with their resources
- Provide resources they can reference about your process or organization

Keeping Campus Partners Informed

Why?

- They cultivate strong connections with students by establishing rapport and trust
- DEIB offices provide support to students from lower economic backgrounds
- Some students may lack knowledge about navigating the campus and identifying the appropriate individuals to address their queries, such as financial aid administrators
- The realm of financial aid is experiencing numerous changes and uncertainties this year

Education Around Financial Aid

On-Campus Partners →

- Recommended contacts for students seeking assistance
 - Example: Guidance on whom to approach if a student is unable to meet their bill payment and information on available options

Recruiting On-Campus Partners, Off-Campus Partners →

- Determining eligibility for financial aid, including clarification on whether international students qualify
- Explanation of the types of aid offered by the institution, including the application processes for merit-based and need-based aid
- Awareness of financial aid deadlines
- Differentiating between whom students should contact for assistance, considering the distinctions between admissions counselors and financial aid administrators, as practices may vary among colleges

Education Around FAFSA Simplification

On-Campus Partners →

- Inform campus partners about the ongoing progress of FAFSA Simplification and its underlying goals to share with students
- Identify sources to address students' inquiries and provide more information about how these changes may impact them
- Highlight the potential alterations to certain students' financial aid packages resulting from these changes

Recruiting On-Campus Partners, Off-Campus Partners →

- Modifying deadlines for financial aid submissions
- Adjusting the opening dates of financial aid applications or scholarship applications
- Inform about the impact of these changes on the timing of the financial aid award letter
- Identify individuals or resources available to address additional questions

Ensuring Campus Partners Stay Informed

How does Carnegie Mellon's Partnership Management Team work to enhance awareness of financial aid information?

- Arranges on-campus partner presentations for enhanced engagement
- Features updates or important reminders about financial aid in quarterly newsletters addressed to high school counselors
- Enhances communication efficiency with campus partners by designating a point of contact
- Facilitates the establishment of office-wide liaisons for distinct academic and non-academic departments

- Distribute an email at the commencement of the financial aid season (October 1st) containing reminders, updates, and relevant information.
